Update from Doug on presentation to Advocates for a better Barrington.

Doug left some info with them at their last meeting and will try to get on their agenda for the next meeting. They do a mailing list; maybe we can access the voters list.

He mentioned to contact the "Town Democrats" to introduce the ordinance to.

Doug mentioned he talked to "New England Grassroots Environmental Fund; NEGEF" Julia Dundorf. They have an emergency fund. We could request some money from them for a public forum or a mailing.
