3. Molly Donovan – UNH Cooperative Extension

Molly described the Community Profile Program offered by the University of New Hampshire Cooperative Extension. The visioning process is conducted to determine what the citizens would want their community to look like in 10 years or more. The Cooperative Extension would help with organizing

Community forums and workshops and work through different methods of data collection for the boards use with updating the Master Plan. Brief bullet points from the discussion are listed below.

Community Profile and Master Plan Visioning

- Help identify a steering committee
- Takes four to six months
- Plan for a day for town to come out
- Friday night and all day on a Saturday
- Help to reach out to community identify stake holders
- Themes which mirror chapters in the Master Plan
- Identify hot button issues
- Facilitators are trained and used at the Friday /Saturday event
- Friday & Saturday identify who brings food
- Start with big picture
- Narrow down to ten or eleven hot issues
- Place people in groups to discuss issues
- Saturday report on identified issues then people pick what group they want to work in
- Use dot system to identify priorities
- Will provide staff for six months to work on action plan

Smaller process for Master Plan Visioning

- Work with board to get people out to visioning session
- Will bring own facilitators
- End up with key concepts
- 10 or less on steering committee

Meet once a month with assignments

- \$500 for Visioning
- Approximately \$1,500 for Community Profile Program
