## CALL TO ORDER

Barrington Conservation Commission (BCC) Chair John Wallace called the meeting of January 19, 2017 to order at 7:00.

**DELEGATION OF VOTING MEMBERS** Chair John Wallace confirmed the presence of members as above.

- 1) Sightings An otter on Swains Lake and a Sharp-shinned hawk were sighted. Unfortunately, Marika's attempt to save a small bird was unsuccessful.
- 2) Guests: Alena Warren, Strafford County Conservation District; Doug Bogen to observe meeting; Dan Ayer as public citizen. Alena shared that soil and water conservation has been the focus of the SCCD, but some work has been done with wildlife and forestry. The group works closely with NRCS and helps farmers and landowners by providing equipment for rental and holding workshops related to soil management. Currently the SCCD is working on an inventory of farms in Strafford County and techniques for nutrient management. Alena mentioned that she would like to open up lines of communication with the BCC.
