CALL TO ORDER

Barrington Conservation Commission (BCC) Chair John Wallace called the meeting of February 2, 2017 to order at 7:00.

DELEGATION OF VOTING MEMBERS Chair John Wallace confirmed the presence of members as above.

- Sightings The groundhog (aka Punxsutawney Phil) did see his shadow so we are expecting 6 more weeks of winter. Mr. Pohopek noted that many (male) deer still have antlers on. They could be in cahoots with the aforementioned Punxsutawney Phil. Pam reported a large nocturnal bird and surmised it was probably an owl.
- 2) Guests: Dan Ayer as a public citizen. Derek Small from Wildlife Encounters of Rochester.
 - a) Jason Pohopek, minimum expedited dredge and fill permit (Hale lot Weeks Lane) Mr. Pohopek explained that this is the same permit for a wetlands crossing that was previously approved in 2005, but has since expired. He mentioned that the Natural Heritage Bureau had no hits. The crossing is about 20 feet wide with an anticipated 398 sf wetlands impacted. The group reviewed and discussed the plans and decided there were no concerns.

Pam Failing made a motion to support the minimum impact expedited application. Marika Wilde seconded the motion, which passed unanimously with a vote of three (3) to zero (0) in favor. John signed the applications.

b) Marcia Gasses, Barrington Town Planner Marcia said that all files and records regarding easements and town properties should be electronically sent to her and kept on the town server. Pam had a question about the ease of using the GIS

mapping system, and it was mentioned that a brief workshop/tutorial on use of the GIS would be helpful. John will look into setting a workshop time and date. There was discussion about creating a recording spreadsheet for the town owned parcels and possibly all easements. Pam mentioned that this could also provide a format for logging volunteer hours. Marcia stated that a spreadsheet is something that the town offices will be able to help set up, and she will check to see what Dover has done in this area. Marcia also mentioned that she can assist the BCC with research/letters that need attention. BCC members can contact Marcia when issues come up that need to be addressed.

- c) Derek Small of Wildlife Encounters (Rochester NH) is looking to relocate his environmental education business that involves housing non releasable animals and outreach to schools and the public. Mr. Small also has an interest in creating a science center to educate about conservation, permaculture, and regenerative agriculture. Mr. Small said he is looking for an area that would allow him to expand his business and possibly include a wildlife rehabilitative center. The group shared possible properties in town, and Mr. Small said he will research available areas.
