### CALL TO ORDER

Barrington Conservation Commission (BCC) Vice-chair Pam Failing called the meeting of August 3, 2017 to order at 6:35.

**DELEGATION OF VOTING MEMBERS** Vice-chair Pam Failing confirmed the presence of members as above.

- 1) Sightings Marika reported that the phoebes second nesting attempt was unsuccessful. Sightings of deer and an osprey were reported.
- 2) Guests: Chris Berg, Wright-Pierce Eng, for Wetland Permit for Rochester waterline and Mike Bezanson, Rochester City Engineer

Mr. Berg and Mr. Bezanson reviewed the work that has been completed at the Rochester waterline. The original pipe was replaced because there were multiple leaks along the line. As a result of this work there is now a section of pipe that is floating above ground, and the proposal is to anchor this section by putting sandbags over the pipe. It was mentioned that they will be working with Marc Jacobs for any necessary restoration work in the area. The city of Rochester will be submitting a major wetland impact application for DES. The group reviewed the plans and decided there were no recommendations or concerns. Final application copies will be signed by Pam. Following this discussion Pam asked about the flow of water in Berry River, and she expressed concern with the amount of withdrawal the city is doing and how this could impact the river downstream. Mr. Berg explained that there could be increased withdrawal in the spring when the flow is higher in order for the city to store more water. Flow gauges have been installed upstream and

downstream from the dam/inflow pipe, and Anne and Pam expressed interest in having data from these flow gauges. Mr. Berg will be sending this data.

- 3) Complaints: DES is following up on a violation of a beach being put in on Cottage Lane (Swain's Lake).
