Letter to Selectmen and Town manager with phone #'s Nottingham and Barnstead Selectmen for them to contact – Letter was shared with Committee

Update from Doug on presentation to ABB. Will ABB put BWPC ordinance or shorter write up in their newsletter? Shall we offer them some money to offset cost – Doug has not talked to them again.

Update Doug – SOG (Save our Groundwater) Doug talked to Marike Wilde of SOG – she is supportive; but was busy with family. Doug will follow up with her.

Russ: Warrant Article signatures to town hall. Meet with John Scruton on procedure. Russ has brought signatures to the town hall; 78 in all. He spoke with John Scruton, who said he would post the whole ordinance on the town website. He also said **we** are responsible for printing and distributing the ordinance at the Deliberative session. There have never been more then 125 residents to attend the Deliberative session according to the town secretary.

Grants: NEGEF and possibly NH Community Rights Network – NEGEF Grant has been approved for \$1000. Gail is looking into some grant money from NHCRN for materials.

Bank account and EIN – For NEGEF we had to get an EIN and Bank account in order for us to receive a check for \$1000 from them; both are in place. Bank account is with Federal Savings Bank. The Committee voted in favor of having the account managed by Cilia Bannenberg. The Committee President, Jim Conley, signed a letter authorizing Cilia Bannenberg to be the keeper of the BWPC official bank records.

Brochure – We edited the brochure. The plan is to mail the brochure in the week of January 20 to every resident in Barrington.

John Wallace will ask ConCom for permission to post the Ordinance on their website.

Gail – Loraine Hansen – Gail said Loraine said she will do her best to come to the Deliberative session on February 1st. Gail will ask Gordon Preston, Selectman of Barnstead, if he will come to the Deliberative session.

Gail presented the Committee with the Barnstead Declaration – NHCRN – New Hampshire Community Rights Network. They meet quarterly in Barnstead. Doug Bogen is considering being the Strafford Representative.
