Item 4- The Board was presented with a letter from Mr. Fred Bussiere of 155 France Road regarding Mr. Bussiere's concern with water in his basement at his property known as Avanti Salon located on Route 9 west of the Circle K/ Irving Gas Station. ## Item 5- Road Acceptance:

Autumn Lane - The Board of Selectmen gave final approval for road acceptance on October 4, 2010. Oak Hill Drive – The Planning Board awaits final recommendation and review of As-built Plan from Consulting Engineer, William Rollins, P.E., of The Louis Berger Group and Barrington Road Agent, Peter Cook.

Item 6- Discussion ensued regarding verbal request for privileged Attorney/Client Information by Mr. Ken Grant. Legal Counsel Jae Whitelaw responded with the following opinion: 1. the request should be in writing; 2. The Planning Board may provide the information, but by doing so, the Board is waiving attorney/client privilege; 3. In addition to waiving this privilege, this action will set a precedent for future requests for information. The Board was not in favor of sharing privileged information.

Item 7- The RFQ (Request for Qualification) is available for review on line at the Land Use web page. This is a two part RFQ. Attachment A specifies an RFQ for Planning Board Review and Construction Service and Professional Engineering Services; Attachment B specifies an RFQ for a Town Office Relocation Study. Nineteen firms attended

the pre-bid meeting on September 30, 2010. First meeting of the subcommittee convened at 4:30 October 14, 2010 prior to the Planning Board meeting to accept nine qualifications for review. Town Planner Connie Brawders and Planning Board member Alan Kelley are members of this subcommittee. The next meeting will follow on October 21, 2010 to score the rankings and make further recommendations.
