### BEACON FALLS CONSERVATION COMMISSION Monthly Meeting Minutes March 2, 2015 (Draft Copy-Subject to Revision)

# 1. Call to Order/ Pledge of Allegiance

Chairman Diane Betkoski called the meeting to order at 6:38 PM.

- Recommended member Lori Paradis Brant attended meeting; gave a brief bio: currently works for non-profit environmental education career, worked for Stepping Stones museum, DEEP, CT Audubon, presently works at CT Forest & Park Association

### 6. Budget Update

• Variance Report for January

Received a request from the Board of Selectmen to submit the Conservation Commission's 2015-2016 budget. D. Betkoski noted that the town budget process review was just beginning.

### • Land Acquisition bank account

Received a corrected bank statement dated 12/31/14 showing a \$1,000 balance; previous fees were reimbursed

• 2015-2016 Budget Submission

D. Betkoski shared with the commissioners the 2015-2016 budget and 5-year budget projection submitted to the Board of Selectmen with a 3% annual increase to the Clerk and Expenses line items and increases to the Land Acquisition line item.

• Review of 2014 goals:

D. Betkoski reviewed and provided status of the Conservation Commission's 2014 Goals:

- update ordinance & clarify processes; waiting for P&Z to update their process to include the Conservation Commission to be actively

involved in new developments

- open space preservation fund: successfully established, and named consistently in the ordinance
- update open space inventory and confirm the deed states it is for in perpetuity; checking for consistency with wording in deeds
- develop plan to identify future properties to purchase

M. Opuszynski asked if the Board of Selectmen had agreed that all open space parcels listed in the open space inventory are deeded to the Conservation Commission and if not, how to economically change the deeds

S. Zyla suggested using quick claim deeds to solve this issue.

- defining maintenance needs for open space parcels

- conduct outreach activities: recycling, RiverFest attendance

#### • Potential 2015 goals:

- M. Opuszynski suggested having a WRHS student representative attend Conservation Commission meetings to help get some student involvement and start conservation efforts at the school.
- S. Zyla commented that she was working on presentations to give at area high school through the Valley Audubon group explaining the group and how they can help, and provided focused activities for students.
- \* establish a student volunteer position on the Conservation Commission
- \* get approval and ratification of updated ordinance
- \* establish subcommittees:
  - Land Use Recognition & Grants Open Space Inventory
- \* Outreach/education can include publicizing what the Conservation Commission does and inform the community; consider starting a blog that the student representative could oversee
- S. Zyla shared a brochure she created about litter which the Conservation Commission could use with their logo
- D. Betkoski emphasized the importance of keeping the CC web site up to date.
- M. Opuszynski suggesting offering an invasive species talk, open to public, and advertise in newspapers.
- D. Betkoski asked everyone to think of other topics of interest.

- M. Opuszynski asked what the definition of passive recreation was in the ordinance; D. Betkoski noted that it needs to be clarified.
- D. Betkoski added that target dates need to be assigned to the 2015 goals.

M. Opuszynski suggested partnering with other town Conservation Commissions to offer joint presentations to increase attendance and awareness.

- <u>ACTION</u>: D. Betkoski will write an article on the environmental impact of cigarette butts.

- Riverfest/Duck Race Saturday May 9: recycling theme have giveaways: magnets and hiking bags suggested showing a poster of what is recyclable and what isn't
  - L. Brant suggested having a recycle challenge: a competition of sorting recycling versus trash; interview the winners for a future newspaper article
  - M. Opuszynski will check on the Girl Scout troop to see if they can attend and bring attention to their cleanup efforts at Lantern Ridge.

The Towantic Hill Power Plant must be built by 2018; it will run on gas/oil which is not green energy.

S. Zyla added that CT doesn't need power, it would help New England and it could be built anywhere in New England.
