**MEETING MINUTES** November 14, 2017

## 1. Call to Order/Pledge of Allegiance

Chairman Ruth Burritt called the meetingto order at 6:30 pm.

#### 4. <u>Approval of Minutes</u>

M. Opuszynski moved to accept the minutes of August 8, 2017. Seconded by S. Zyla. Three in favor, one abstains. Motion passes 4-0.

#### 5.<u>Correspondence</u>

Discussion regarding a request received last month from Judy Treu of Yale/Griffin Research Center through Diane Betkoski for maps of Lantern Ridge Park. R. Minnick believed the Conservation Commission did not possess the info requested by the Yale/Griffin Research Center.

1. B. Burritt stated he will repair the plexi-glass on the kiosk at Lantern Ridge Park.

### 7.<u>New Business</u>

1. Discussion regarding the possibility of replacing the various park locations utilizing plexi-glas with a stronger, more resilient material such as Lexan. S. Zyla suggested contacting Heritage Glass for guidance.

2. R. Burritt stated the Conservation Commission will be requesting a meeting with the Board of Selectmen in the near future to discuss pertinent issues involving the Commission.

3. Plans to restock Toby's Pond and D.E.E.P. recommendations were debated. Type of fish, cost, and a time line were briefly discussed.

4. Paid membership in the National Audubon Society was discussed. Cost, advantages, etc. were considered.

5. Discussion, R. Minnick & M.Opuszynki, re: trail activity at Lantern Ridge Park and contacting potential organizations to help with fish studies at Toby's Pond
