MINUTES:

Minutes of the April/2016 EDC Meeting were reviewed. **D. Phipps moved to accept as presented.** Seconded by J. Rodorigo. All ayes, motion carries 5-0.

PUBLIC COMMENT:

Joe Rodorigo, Chairman of the Board of Finance, addressed the Commission explaining the current state of affairs regarding the 2016/2017 proposed Town budget. Joe was emphatic in telling the Commission that requests for funding/budget changes would be reassessed throughout the fiscal year as warranted. Joe expressed a need for the EDC to work closely with the other Boards & Commissions in town to streamline the process for a potential commercial or industrial tenant to utilize in the decision making process and to seriously look into hiring an individual to assist in this process.

- 1. Initial contact with State D.O.T. regarding extending the downtown walkway from Bethany Rd. south to the Riverbend Park area appeared optimistic. This project is very preliminary at this point.
- 2. Downtown maintenance bid discussed. They are to cover the medians and the bottom of Exit 24.
- 3. The apparent low local turnout at the Duck Race last week was discussed with considerable concern.

NEW BUSINESS:

- 1. J. Rodorigo made a motion to accept Amity Gardens maintenance contract for the downtown medians and the area at the bottom of Exit 24. The agreement for \$2000.00 will cover all medians and the Exit 24 area. Seconded by K. Trzaski, all ayes. Motion carries 5-0.
- 2. J. Rodorigo made a motion for the EDC to pass along its wholehearted support regarding the reappointments of Robert Bradley & Ed Korzon to the EDC as soon as possible, to the Board of Selectmen. Seconded by D. Phipps. All ayes, motion carries, 5-0.
- 3. With tonight's comments from Board of Finance Chairman Joe Rodorigo in mind, **D. Phipps made a motion to name EDC Commissioner Kristen Trzaski liaison to compile available commercial & industrial properties and assist with completing the EDC marketing package. Also, to secure a cell phone to be answered by the EDC clerk with pertinent information, inquiries, etc. being answered and/or referred to an EDC Commissioner in a timely fashion. Seconded by J. Rodorigo. All ayes, motion carries, 5-0.**
