Selectman Mike Krenesky was present for a portion of the meeting. Mr. Krenesky updated the EDC re: status of the Library/Community Center. Mr. Krenesky requested the Library/Community Center Project be added to the January 2018 EDC meeting agenda.

Sadie has been reviewing the info from previous studies of downtown. She attended the Valley Chamber Meeting along with looking into State owned parcels in the industrial park. Sadie will be investigating the possibility of State grants to assist in marketing the industrial park. She will also be contacting local developers regarding new projects.. She will also be reaching out to Mario Trebka regarding the Rau property on So. Main St. along with contacting Haynes regarding redevelopment project along the river south to the Seymour town line.
