

VII. PUBLIC COMMENT

Derek Muharem of Prospect stated that the budget handout could have been printed double sided to save costs. He said people are still confused about 3rd grade teachers being pulled out at Algonquin. He asked about the timeframe for the Interim Superintendent. Ms. Cretella responded he's per diem now, and the Board will discuss a contract after the budget process. Mr. Muharem said he heard rumors of a retired principal from Orange being hired. Ms. Cretella said the rumor is not true, and nothing has changed from what was answered previously. A Search Committee will be set up in the near future.

Catherine Mirabilio again asked for answers she hasn't received. She said the superintendent's secretary came up to her at the break and asked her to submit her questions in writing. Ms. Cretella again told her she will have answers tomorrow. Ms. Mirabilio asked why some Board members speak to the public and some do not and that her phone calls have not been returned. Ms. Cretella said they were returned.

VIII. CORRESPONDENCE

Sheryl Feducia read a letter from Michele Papa, Department Head of English, asking to relook at restoring an English position. She stated this teacher is involved in other capacities within the school.

A MOTION was made by Sheryl Feducia to reinstate the English position. There was no second to the motion.

Ms. Cretella stated there are three confirmed early teacher retirements totaling a reduction of \$60,000.

Mr. Potter stated this brings the proposed budget for 2012-2013 to \$37,295,943 or a 1.44% increase. The town shares are \$203,403 or 2.19% increase for Beacon Falls and a 3.55% increase to Prospect or \$528,484.

A MOTION was made by Robert Hiscox and SECONDED by Sheryl Feducia to approve the proposed budget for 2012-2013 at \$37,295,943.

Mr. Stan Pilat, Vice Chair of Prospect Town Council, stated a town meeting is more representative to approving the budget than a referendum.

Ms. Hiscox stated the last time the budget was voted on a town meeting it was chaotic. He recommends setting up a traffic pattern for voting. Ms. Cretella said registered voters would still have to stand in line to be checked off, which will take time. Mr. Hiscox stated it should be done better this time with logistical planning and where to set up the voting. Cost for ballots and registrars were estimated at \$1500 by Mr. Stowell.

A MOTION was made by Robert Hiscox and SECONDED by Robin Wright to hold a regional district meeting at Woodland Regional High School on May 7, 2012, at 7:00 p.m. for the purpose of voting on the proposed 2012-13 budget by paper ballot.
