Doiron asked whey there was a difference in monies paid to the Council of Governments, with S. Cable noting extra c osts a re i neurred d ue to hazardous materials and electronics collections. M. Krenesky asked why there is such a large transfer to First Selectman's Secretary Line Item. S. Cable noted that monies had to be transferred from Contingency to cover salary increases from the 2009/2010 fiscal year. Clerk K. Wilson suggested M. Krenesky note that all Town Employees needed to have a transfer of funds for the same reason given by S. Cable. Vote on the motion: All aye. Memo will be sent to Finance Director asking for a written explanation as to budget transfers to cover salary increases for Town Employees

PAYMENT OF BILLS

R. Doiron made motion to approve K. Wilson's invoice for \$35.00. 2nd by L. Krepinevich. All aye.

BOARD OF SELECTMEN

- 1. S. Cable noted she had signed Contract with Town Auditor M. Zemaitis. She feels he will have audit completed on time in December.
- 2. S. Cable noted Finance Manager is working with Town Clerk on that office's Financials.
- 3. S. Cable noted bond package is being worked on to include: serious repairs to some Town roads, pay loader for Public Works, new ambulance and new ladder truck.
- 4. The Board of Selectmen and Board of Finance should meet with Prospect Mayor and its Town Council to discuss more accountability from the Board of Education.
- 5. S. Cable noted Board of Selectmen will send letter to the Board of Education with regard to opposition from the Town of Beacon Falls to help pay expenses for a new water line in Prospect. She noted Town also has some issues with the Tallmadge Road property with regard to proposed zone changes in Prospect.
- 6. S. Cable noted Board of Selectmen and Board of Finance should meet sometime in September with the Board of Education. No numbers are known at this time with regard to student populations of both Beacon Falls and Prospect.
- 7. S. Cable noted Fire Department had received a \$2500 grant to offset brush truck and related expenses.
- 8. S. Cable noted tank at the Peter Paul facility on Railroad Avenue has been approved by the DEP for Town's storage of diesel fuel, resulting in a savings of funds. She added existing tank would be removed.
- 9. S. Cable noted various STEAP funds are being applied for.
