Regular Meeting Minutes February 16, 2012 Draft Minutes Subject to Modifications

Present: Vice Chairman Chadderton, Commissioners Taylor, Fitzpatrick, Burns, Hinman, Groth, Trzaski, Betkoski and Setaro.

#### I CALL TO ORDER

Vice Chairman Chadderton called the regular meeting of the Beacon Falls Planning and Zoning Commission to order at 7:30 P.M.. followed by the Pledge of Allegiance.

#### II APPROVAL OF MINUTES

A motion to approve the minutes of the Jan 19, 2012 regular meeting as submitted was made by Comm. Fitzpatrick 2<sup>nd</sup> by Comm. Betkoski. 8 in favor. 0 opposed. 1 abstention.

\*\* Vice Chairman Chadderton introduced the newest member of the commission, Dominic Setaro, to the other members of the board.

#### III COMMENTS FROM THE PUBLIC

Vice Chairman Chadderton asked 3 times if there were any comments from the public and no one came forward.

## IV ZONING ENFORCEMENT OFFICERS REPORT

The ZEO was in attendance and submitted a written report that showed 3 certificates of zoning compliance were issued - 7 Skiloa Drive, Fence/Horse,14 Dolly Drive, Sunroom and 164 Cook Lane, Shed. A motion to accept report as submitted was made by Comm. Fitzpatrick and 2<sup>nd</sup> by Comm. Trzaski. All in favor.

The Town Engineer was in attendance but did not submit a written report. He stated that he had nothing to report. Comm. He stated that it is his intention to open March 1, 2012. The hours of operation will be Mon Sat 11-8. After a brief discussion which included the fact that this business meets all of the requirements and that the signs also meet requirements, according to Brian Herb, ZEO, a motion was made by Comm. Trzaski to approve and 2<sup>nd</sup> by Comm. Fitzpatrick. 8 in favor. 1 opposed. 0 abstentions.

  3) Bomba Ind LLC discussion on cease and desist This is a situation in which several businesses are renting space at 304 Lopus Rd, and the town requires an A2 survey, which the renter believes should be provide by the owner and has been trying to get the Landlord to cooperate. His business is auto repair, he is working on getting a state license. He is currently just doing prep work on the space that he is renting.

Comm. Trzaski spoke up and noted that he was reappointed to the Land Use Board, without sending a letter of interest, and said no thanks, please find someone else. He was informed that he needed to send in a letter of resignation.

Comm. Hinman stated that normally commissioners abstain from voting if they are not up to date on the matter before them. She wanted to know if there were any regulations that prohibited a newly appointed member from voting when he/she was not familiar with the internal workings of the commissioners. She was informed that once a person is appointed and sworn in, that there were no conditions put on that new member as far as voting is concerned.

Comm. Trzaski asked 3 times if there were any other nominations and no one else was nominated. A motion to cease nominations was made by Comm. Fitzpatrick and 2<sup>nd</sup> by Comm. Taylor.

A vote by show of hands was taken and the results were 5 for Dave Chadderton and 4 for Peter Betkoski.

Nomination for Vice Chairman was made by Comm. Hinman and 2<sup>nd</sup> by Comm. Burns for Peter Betkoski.

Nomination for Vice Chairman was made by Comm. Chadderton and 2<sup>nd</sup> by Comm. Groth for Joe Fitzpatrick.

No other nominations were made and Comm. Chadderton motioned to cease nominations and Comm. Fitzpatrick 2<sup>nd</sup> it.

A vote by show of hands was taken and the results were 5 for Peter Betkoski and 4 for Joe Fitzpatrick.

A motion to nominate Donna Taylor as secretary was made by Comm. Chadderton and  $2^{nd}$  by Comm Hinman.

No other nominations were made.

A vote by show of hands elected Donna Taylor as secretary.

Comm. Betkoski noted that now that elections are over, that everyone needs to work together like before.
