He would like to see if additional on and off ramps on either side of Lopus Road would be able to be put into the plan so that maybe funding could be found for the project. If it is not in the plan then it can not happen.

1)Watch Hill – No representative in attendance. Subject was addressed in the Town Engineers report.

2)Chatfield I – Matthew Gilchrist, principal with EG Group, came forward and introduced himself to the commission. He informed the board that they are in the final stages of a contract to develop Chatfield Farms. There are 4 models currently, which will not be used as their models and he would like to be able to obtain Certificate of Occupancy for them once they are independent of each other. After a brief discussion, Comm. J. Trzaski made a motion to allow Brian Herb to issue the certificates (once qualifications are met) and it was 2nd by Comm. Gigilio. 7 in favor. 1 abstention by E. Groth)

3)Regulation Updates – Bids from Nafis and Young were obtained to update the book of regulations to bring up to current – Dave Chadderton and Jim Galligan will develop policy and procedures for zone change updates.
