VII COMPREHENSIVE PLAN OF CONSER. & DEVELOPMENT

1)Watch Hill – Paul Crotta was present and gave the commission a progress report. A motion was made by Comm. J. Fitzpatrick and 2nd by Comm. B. Giglio to grant a 30 day extensiion to compelte the site work. All in favor. *Comm. R. Jurzynski returned to the meeting.

2)Chatfield I – Matthew Gilchrist, principal with EG Group, came forward and presented the commission with a proposed site plan revision. The project as currently approved includes duplexs. He feels that there is not a market for those units. Also, currently, they have approval for the units to be 10 ft in distance and they plan to spread the separation to 17-18 ft. They will be replacing the roads. Al Torratone, Pres. Of the association spoke and said that they would like to minimize sidewalks where not necessary and change the curbs.

A motion to accept the site plan revision proposal was made by Comm. B. Giglio and 2nd by Comm. D. Setaro. All in favor.

A motion to approve the site plan revision for P-2013-195 with conditions was made by Comm. J. Fitzpatrick and 2nd by Comm. B. Giglio. The conditions are A) with additional backup information as requested by the Town Engineer, B) excluding curbing, wetlands C) payment of the \$500.00 site plan revision fee.

3)Pond Spring Village – No activity.

4)113/119 Main St – Marcus Puttock came forward for the applicant and stated that they would like to alter the site plan. The plan is to move the building 10 ft from the road. The retaining wall across the back will be 12 ft At the tallest point. They need a larger easement from the owner and the Parking spaces will remain the same in quantity. The discussion was tabled until next month.
