6)Hillside Estates – A brief discussion in which Chairman K. McDuffie mentioned the driveway issues being a concern because of the common driveways. The applicant submitted a written request for an extension until the regular meeting of April 17, 2015. It was accepted by the commission.

- 1)Chatfield Farms Matt Gilchrist was present and gave an update on the project. He noted that wetlands approval is given, the board needs a copy of it.
- 2)Civil One It was noted that the wetlands approval has expired, a bond is in place to the town.
- 3)Oakwood Estates No bond or mylar yet. Check was sent to the Board of Selectman, should have been sent to Planning and Zoning.
- 4) Pond Spring Chairman K. McDuffie will check into if the bond or mylar have been filed.
- 5)Tiverton Comm. R. Jurzynski said that the project looks good, he would like to see the remaining 2 lots with houses on them, he feels that it would best cover the town when a decision is made on this application. Aquarion and the Fire Chief need to agree before a decision is made.
