

**BEACON FALLS PARK AND RECREATION COMMISSION

**CALL TO ORDER**

S. Ruhl called the Regular Monthly Meeting of the Beacon Falls Park and Recreation Commission to order at 7:00 PM.

**MINUTES**

**B. Egan made a motion to approve the June, 2014 Regular Meeting Minutes, as presented. J. DeGennaro seconded the motion. All ayes.**

**COMMENTS FROM THE PUBLIC**

Tabled until the arrival of Don and Elaine Ferretti.

**OLD BUSINESS**

**A. MATTHIES PARK**

1. Regular maintenance continues at Matthies with some removal of dead trees and the pond water being treated on schedule.
2. The Cub Scouts will be holding a conservation clean-up at the park on Sunday, October 5<sup>th</sup> from 10:00 AM until noon.
3. M.E. Fernandes asked what happened to the signs which were put up by the new bridges. Those signs were taken down and should be replaced, as they provided useful information about pedestrian traffic.
4. The Haunted Hayride will take place at Matthies on October 25<sup>th</sup> and 26<sup>th</sup> and Parks & Rec members can help out the Rotary Club with this event.

**B. PENT ROAD**

1. S. Ruhl reported that Pent Road is very busy with Flag Football, Jr. Hawks, RACBL, Baseball and Softball Leagues, Prospect Soccer games, and the NACBA.
2. There was some discussion about the NACBA having field space ahead of one of the leagues. S. Ruhl explained that NACBA got their application in early and to get better playing times, leagues should get their applications in earlier.
3. D. Palange noted that the field conditions have been very good. S. Ruhl explained that Fields #3 & #4 will be torn up shortly, which will affect Softball practices.
4. S. Ruhl also noted that Wednesday nights and Friday nights are usually open for practices, if a team is looking for open field time.

5. D. Palange noted that RACBL had equipment stolen due to vandalism. S. Ruhl responded that a resident will be installing cameras at Pent Road. D. Palange noted that the basketball lights have been turned off earlier in the evening.
6. Regarding batting cages, D. Palange noted the RACBL wants to know when work will be done before they order materials. S. Ruhl explained that once the materials are delivered, we can schedule the work crew for the same day. Work can begin the same day the materials arrive. D. Palange hopes to use a local construction company. RACBL does not want to pay for materials if they will just sit. S. Ruhl assured D. Palange the material will not sit.
7. D. Palange also noted there are lights out on the first base line. The town will be renting a cherry-picker truck for the netting in the spring and will address the lights at that time. It is an expense to rent a cherry-picker, so unless the fire department can provide access to the lights earlier, the work will be done in the spring.
8. S. Ruhl advised A. Sirowich that a missing bag of dodgeballs which belonged to the Summer Recreation Program was returned to Pent Road. Everyone is more aware of the need for securely storing items at the park.

**C. RIVERBEND PARK**

B. Egan reported that the committee will be meeting on October 8<sup>th</sup>, as they have not met in several months. The grant funds are still there and some reporting needs to be addressed, so that records are in the correct format for the State.

**D. SPORTS LEAGUES**

1. Flag football will be wrapping up in November, RACBL ends on October 26<sup>th</sup> or so, and Jr. Hawks also ends in November.
2. Beacon Falls Basketball League is holding sign-ups October 6 – 8 at Laurel Ledge. The league will be faced with space issues dependent on how much space is available at Laurel Ledge cafeteria/gym this season, due to the construction at the school. They will need to apply with Region 16 and use Woodland as much as possible.

**E. PARK ACTIVITIES**

1. J. DeGennaro is running a Volleyball Camp for 4 Saturdays in October at Woodland. She has had enough responses to run the camp.
2. Zumba for Kids will take place at Laurel Ledge after school on Wednesdays from October 8 – November 12. Tracy Brody will be running this class.
3. Haunted Hayride will take place October 25 & 26 at Matthies Park and commissioners can help out.

- B. He noted that Land Use indicated that they would like Parks & Recreation to be involved with Toby's Pond, which is not something this board is in favor of.
- C. S. Ruhl noted that with all the mini-parks in Town like Veterans and Volunteer Park, along with Matthies and Pent, the town crew is stretched thin. A. Sirowich noted the budget would be big concern for maintaining Toby's Pond, along with liability issues there.
- D. S. Ruhl was thinking about asking volunteer groups, like the Boy Scouts, Girl Scouts and Cub Scouts to "adopt" a section of the town median to weed and maintain. The town crew would mow the areas, but the Scouts could weed and plant flowers to make them look nicer. Representatives present from Troop 104 are willing to help.
