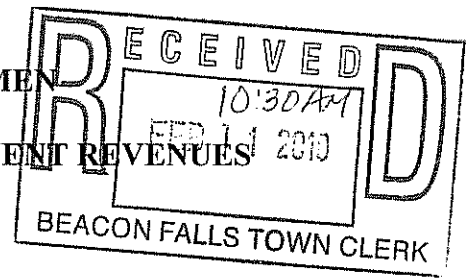


BEACON FALLS BOARD OF SELECTMEN  
SPECIAL TOWN MEETING  
BUDGET APPROPRIATION FROM FIRE DEPARTMENT REVENUES  
TO AMEND CURRENT 2009/2010 MUNICIPAL BUDGET  
FEBRUARY 8, 2010  
MINUTES



First Selectman S. Cable called the Special Town Meeting to order at 7:35 P.M. with the Pledge of Allegiance. S. Cable asked for a moment of silence in honor of those who lost their lives in the Middletown explosion on 2/7/10.

**ALSO PRESENT:** Selectman M. Krenesky, Selectman D. Sorrentino and Finance Manager, M. Gomes.

**ALSO PRESENT:** Quorum present. At least thirty-five (35) members of Beacon Hose Company No. 1.

Temporary Clerk read call of Town Meeting. **B. Cloney made motion to accept call as read, 2<sup>nd</sup> by D. Bousquet. All aye.**

**Jeremy Rodorigo made motion that vote be by show of hands, 2<sup>nd</sup> by R. Brennan.** M. Mulinski and M. Pratt were appointed to serve as counters. **Vote by show of hands: YES: 34, NO: 0, ABSTENTIONS: 0. Vote will be by show of hands.**

**M. Krenesky made motion to appoint K. Wilson to serve as Permanent Clerk for this Town Meeting, 2<sup>nd</sup> by Jeremy Rodorigo.** With no other nominations three (3) times, K. Wilson will serve as Clerk for this Town Meeting. **All aye.**

**Jeremy Rodorigo made motion to appoint First Selectman S. Cable to serve as Permanent Moderator for this Special Town Meeting, 2<sup>nd</sup> by B. Cloney.** With no other nominations, S. Cable will serve as Moderator for this Town Meeting. **All aye.**

S. Cable thanked everyone for attending this Meeting, noting purpose is to approve a transfer of funds in amount of \$18,894 from Fire Department Revenues to amend the current 2009/2010 Municipal Budget. She noted extra revenues were received but that repairs to the Railroad Avenue property cost more than originally anticipated.

**B. Cloney made motion to approve the above noted additional appropriation of \$18,894 from the Fire Department Revenues to amend the current 2009/2010 Municipal Budget, 2<sup>nd</sup> by J. Rodorigo. Vote by show of hands: YES: 35, NO: 0, ABSTENTIONS: 0. Motion passed.**

**M. Krenesky made motion to adjourn the Special Meeting at 7:40 P.M. 2<sup>nd</sup> by D. Bousquet. Vote by show of hands: All aye.**
