# BEACON FALLS BOARD OF SELECTMEN Regular Monthly Meeting July 11, 2011 MINUTES (Draft Copy-Subject to Revision)

First Selectman S. Cable called the Regular Monthly Meeting of the Board of Selectmen to order at 7:30 P.M. with the Pledge of Allegiance.

PRESENT: First Selectman S. Cable, Selectman D. Sorrentino and Selectmen M. Krenesky

ABSENT: None.

ALSO PRESENT: Approximately 8 town residents

S. Cable commented that Parks did a wonderful job on the fireworks. She noted that she will be sending a letter to the effect.

#### **PUBLIC COMMENTS**

J. Rodrigo, 42 Bonna St., commented that the decision on the Wolfe Ave. project has already been made and voted on. He believes it would be a mistake to go backwards. He noted that many Boards had input in the information that was voted on. He encouraged the BOS to move forward with demolition of the house.

- W. Classey, 28 Wolfe Ave., noted that the parking lot at the town hall looks very nice and wonders why there are no crosswalks in town. He noted that there are no crosswalks on Burton Road, Wolfe Ave. to Maple Street, etc.
- S. Cable responded that this was a good point.
- J. Woodward, Wolfe Ave., noted that there is a movement in town to make the hill section into a historical area and the Tracy Lewis house would be the point of it all. He noted that other towns have heard about this property and efforts and are beginning to come forward to help. He noted that there is conflicting information out there.
- S. Cable responded that there is no conflicting information. She noted that the town has not authorized to make the hill section a historic district.

A discussion continued between J. Woodward and the BOS regarding the efforts so far being grass roots and how they would go about turning the area into a historic district. M. Krenesky noted that a historical district has to be set up.

S. Dowdell asked under who's authority would this be made a historical district. J. Woodward noted that the movement at this point is grass roots.

It was noted that if a decision was to be made, it would be by the BOS and all the neighbors would definitely be a part of the decision.

## **OLD BUSINESS**

#### Ordinances

The BOS will be scheduling a meeting re ordinances, the service award and local tax relief. A discussion continued regarding the amount.

M. Krenesky motioned to eliminate the last sentence on page 2 of the new ordinance. D. Sorrentino 2nd the motion. All voted aye.

A discussion continued.

The town meeting for a vote on the ordinance will be held on Monday July 25th at 7:00 to vote on these three ordinances.

Wolfe Ave.

S. Cable recommended that the town have an informational meeting regarding Wolfe Ave. to explain the steps that have already been taken and to review the resolution. She noted that not once was the Tracy Lewis house's historical value mentioned in any meeting minutes and reiterated that the votes were 99 to purchase the house, 66 to not purchase the house.

- M. Krenesky asked for a clarification of who will be making what presentations at an informational meeting and will the Public be allowed to comment. It was noted that of course people will be able to comment but the bottom line is that the decision has been made.
- D. Sorrentino noted that he could not support the meeting in that the vote had already been made.
- M. Krenesky noted that we need to move forward however the Citizens News is running a weekly poll asking what people would like to see done with the Tracy Lewis house noting that the survey seems to be leaning heavily towards preserving the house.
- B. Katenzeno, Fairfield Place, suggested that the group of people raise the money to do what they want with the house.
- M. Krenesky suggested that until we have a plan with what to do with the property, we hold off on taking the house down.

A discussion continued.

#### Website

M. Krenesky noted that the original plan to go live with the website was for July 15th however there are many blank pages noting that the Conservation Committee has got a good model for other committees to follow.

Discussion: Forms are in bad condition and may have to be reprinted, town Hall people have to be in charge of maintaining the content and training will be set up for everyone. It was also noted that they will identify a person in the town hall to monitor the website. It was noted that it may be Joan.

It was noted that a meeting will be set up to discuss a pay format for clerks and also to discuss personnel issues.

M. Krenesky noted he will only be available in the evenings.

#### **NEW BUSINESS**

A discussion took place regarding the resolution to repave the roads and the sewer improvements.

D. Sorrentino noted that he would like to hold off until all the roads are reviewed since the last winter and storms. Reviewing of the roads is scheduled for tomorrow.

- W. Classey, 28 Wolfe Ave., noted that as far as the vote for the Wolfe Ave. property, nothing was ever said about making fire wood out of it.
- S. Dowdell noted that they have a high school student on the committee to get their input.

A discussion continued.

J. Rodrigo noted that it would be more efficient and less argumentative if they took out an ad in the paper to note every step that has been taken so far regarding Wolfe Ave.

It was noted that this is a good suggestion.

- B. Krenesky, noted that the Rubber Company is what Beacon Falls is all about. She also noted that we have to start preserving some things from the past. She suggested that keep the house and build something next to it. She also noted that she was in that house and there was no mold.
- E. Groth, noted that since they are years away from doing anything with the house there is no urgency and why doesn't the town lease the house for \$1 per year until the ground is broken.
- M. Jursynsky noted that the railroad property wants to be donated to the town and the BOS is deciding on whether it is worth accepting.
- D. Sorrentino motioned to adjourn the meeting at 9:24 P.M. M. Krenesky 2nd the motion. All voted aye.
