NOTICE IS HEREBY GIVEN that the Town of Beacon Falls will conduct a Public Hearing by the Office of the First Selectman on Monday, April 9, 2012 at 7:00 P.M. in the Town Hall Assembly Room, 10 Maple Avenue, Beacon Falls, CT 06403 to discuss the Fiscal Year 2012 Community Development Block Grant program and to solicit citizen input.

Maximum award limits include a total of \$750,000 per Fiscal Year for Public Facilities, \$700,000 per Fiscal Year for Public Housing Modernization, \$500,000 per Fiscal Year for Infrastructure, and \$300,000 per Fiscal Year for Housing Rehabilitation Program.

Major activity categories are Housing - New Construction, Housing Acquisition, Housing-Rehabilitation, Community Facilities/Public Services, and Economic Development. Projects funded with CDBG allocations must carry out at least one of three National Objectives, as follows: benefit to low- and moderate-income persons, elimination of slums and blight, or meeting urgent community development needs.

The First Selectman's Office on behalf of the Town of Beacon Falls anticipates applying for \$300,000 under the housing rehabilitation category for Townwide housing rehabilitation. The Town of Beacon Falls will use funds generated from the program, if any, to continue the housing rehabilitation program.

The purpose of the Public Hearing will be to give citizens an opportunity to make their comments known on the program and for approval of the Program Income Reuse Plan. If you are unable to attend the public hearing, you may direct written comments to the Office of the
