Sewer Service Area Map

Jim Galligan, Town Engineer explained that last month there were two requests to add two parcels to the sewer service area map. There were questions if the siphon could handle the flow from the two proposed projects — Beacon Village and Chatfield 1 & 2. An analysis was done by Nafis & Young. A Siphon Analysis was submitted by Nafis & Young to the board. The report states: the recorded average daily flow at the Railroad Avenue Pump Station from October 1, 2008 through October 1, 2009 was 142 gpm. Estimated Future Flow to the Siphon: Present 142 gpm, additional increase in sewered areas, assume/10% of present — 14- gpm Beacon Village, 84- gpm Chatfield 1- 27 gpm, Chatfield 2- 35 gpm. Total future flow — 302 gpm. Siphon Analysis Criteria — total capacity 2300 gpm. The proposed projects can be put on the sewer service area map.

Jim Galligan, Town Engineer forwarded a copy of the proposed Sewer Service Area map to the board.
