Nitrogen & Phosphorus Removal - Treatment Plant

Chairman Smith noted that the State of Connecticut has turned down the permit. Brian Fitzpatrick stated that there will be phosphorus limits on the permit. The approximate cost for nitrogen removal is \$1 Million. Removal of phosphorus would cost between \$300,000 and \$500,000. The Town is interviewing some firms. This matter will be kept on the agenda. Discussion was held as to funds for the nitrogen removal and phosphorus removal.

#### **New Business**

Chairman Smith noted that the storm drain connected into the manhole #217 on Main Street will be tied in a basin in behind the manhole and run another pipe down to the next basin which will then discharge down into the river.
