Mr. Horbal explained that the proposed site layout and floor plan is for a 5,027 square foot one story office building. There will be seven employees. The application has been filed. The sewage flow has been calculated. The sewage flow will domestic waste. Medical waste will be disposed of by an outside agency. There will be four bathrooms. There is a sewer lateral currently there. There will be a clean out half way. Chairman Smith noted that this line has been Tv'd. The tape
