#### Nitrogen & Phosphorus Removal – Treatment Plant

Jay Sheehan of Woodard and Curran came before the board to give an update on the nitrogen project. He stated a menu of options is to be presented to the Town. They are currently going through the Clean Water Checklist for the proposal. The user fee was discussed with the First Selectman which will be investigated. The study can be done without having rates. There were questions regarding funding from the State if there is no user fee. The funding can be obtained for the plant study without a user fee. There will be no funding for construction. To be compliant to get funding from the State a copy of the RFQ, information regarding scoring sheet or how a decision was made has to be sent to the State before a plan is approved. Town Engineer, James Galligan asked that a list of the process be emailed to him. Jay Sheehan stated that what the State demands is hundreds of thousands of dollars. The State funds 60% of planning. It is a larger number than was previously discussed because it is following the State's guidelines. The original proposal to this board was just looking at the plant nitrogen, phosphorus removal and a little energy efficiency. Commissioner Edwards' suggested to see what the minimum is that is needed to fulfill the obligation to the State versus going all the way and get funding from the State. It may cost two or three times what is really needed. Jim Galligan, Town Engineer stated that First Selectman Smith requested a price to do the nitrogen and phosphorus removal, then a price in a menu form for the others items that can then be analyzed.

Jay Sheehan mentioned the connection into the sewer line by O&G. They have a small evaluation contract. A meeting will be held on February 15, 2012 at 1:30 p.m. The board previously approved the wash plant at the cement plant. The water that is currently recycled is no longer usable for O&G as it is affecting the quality of the cement. They want to discharge this water into the sewer line. Without treatment it will be over 12 on the Ph. Part of the evaluation will be for them to drop the Ph to 8.3 - 8.4 before it is received by the Treatment Plant. Requirements and restrictions need to be determined by the board. There is a partial set of plans. Originally O&G was to tie into the line before the pump station. Now they will go back into the line 60 feet closer to the concrete plant which is upstream. A grease trap and a flow meter were part of the approval. There was no stipulation on the quality of the water that will be received. A fee is also to be determined. It is being researched as to how the chemicals going in will affect the plant. It will be approximately 2,000 to 4,000 gallons per day. These matters were discussed with Ken Faroni, O&G.

Walter Opuszynski, Plant Supervisor stated that there is a problem with the UV control panel at the plant. It was installed five years ago; there is no way to repair it. He is looking to upgrade the panel. He would like Woodard and Curran to look into the technical part.

Jay Sheehan stated they will be consulting with Jim Galligan, Town Engineer. The plan will then go to the board for review and then to the State.

#### West Road – Blockage/Pressure Line/Storm Drain

Chairman Smith stated that a CBYD has been done. The camera could not get up the line. The snake was put through to clean the line but it stopped at the same spot and could not get through. The next option is to dig it up and take measurements for a future manhole.

#### **New Business**

Chairman Smith stated that across the street from the pump station there is a house that tied into the sanitary sewer. They did get a permit. There is no tie in fee as there is an assessment as it is part of the Rimmon Hill Sewer Project. When the contractor installed the line there was no stone or filter fabric. The piping was good. The contractor was required to dig it out, installed the stone and filter fabric as required.
