They are on track with the DEEP Phosphorus Scheduled Milestones. They have put together a comprehensive map of the collection system. They are working on coordinating the survey with the GPS to locate all the manholes. They are right on track with tasks two and three as discussed last month. The collection/sewer system/treatment plant work will coming over the next month or two. Walter Opuszynski, Treatment Plant Supervisor stated that everything is on schedule.

4. O&G Wash Plant

Chairman Jeffrey Smith stated that nothing has been heard from O&G. This matter will be kept on the agenda.

5. Burton Hill, 363 Burton Road – 2 Lot ReSubdivision
