2. Sewer Service Area Map

3. Nitrogen & Phosphorus Removal – Treatment Plant

James Galligan, Town Engineer stated that surveying for the manhole location locations is being done. The Beacon Falls Police Department shut down Nafis and Young for surveying without a police officer present. Chairman Jeffrey Smith feels that some of the areas being surveyed are on side streets and no police officer is needed. First Selectman Gerard Smith will discuss this matter with the Police Department.

As David Prickett, Woodard and Curran is unable to attend this meeting, he forwarded the following email concerning the status of the Wastewater Facilities Plan:

- 1. We continue to collect sewer manhole data, through Nafis and Young, for the collection systems tasks.
- 2. The Beacon Falls Police Department has requested that Police Details accompany Nafis and Young staff during field work; Woodard and Curran to discuss this matter with First Selectman Gerard Smith relative to budget.
- 3. We are looking at WPCF upgrade alternatives for phosphorus, nitrogen and wet weather.
- 4. We have been assisting WPCF with pump station reviews.
- 5. We are beginning development of preliminary cost estimates to generate a capital plan for wastewater needs.
- 6. We have commenced the UV system, review as discussed last month.

4. O&G Wash Plant

There is nothing to report. This matter will be kept on the agenda. David Prickett, Woodard and Curran noted in his email: we have not heard any news regarding the second review letter.

5. Burton Hill, 363 Burton Road – 2 Lot ReSubdivision
