# BEACON FALLS WATER POLLUTION CONTROL AUTHORITY Monthly Meeting August 18, 2015 MINUTES (Subject to Revision)

#### 1. Call to Order

Chairman Jeff Smith called the meeting to order at 7:40 P.M.

## 2. Read and Approve Minutes from Previous Meeting

Motion to accept the minutes from the April 21, 2015 meeting as submitted by the clerk for tonight's meeting: Motion made by R. Pruzinsky and seconded by J. Weed; no discussion; all ayes.

#### 3. Comments from the Public

J. Smith asked if there were any comments from public and there were none at this time.

#### 4. New Applications

There were no new applications at tonight's meeting.

#### 5. Public Hearing

There were no Public Hearings presented nor discussion at tonight's meeting.

#### 6. Old Business

#### a. Mark Tice

R. Pruzinsky indicated that he received a call from M. Tice before digging for the lateral on Ellen Drive. J. Smith indicated that the laterals up and the ones for West Road are done. R. Pruzinsky indicated that the as-builts were given for those. M. Tice was trying to do the connection off the road in the easement going down towards West Road. J. Smith noted that M. Tice paid the \$4,000 per lot.

Nafis & Young inspected the laterals. The tie-ins are all done off of West Road.

#### b. Nitrogen & Phosphorous Removal

There was no one here at the meeting tonight to discuss the Nitrogen and Phosphorous Removal.

#### c. Pump Station

A report was submitted by W. Opuszynski. R. Pruzinsky noted that there are a lot of sludge loads being taken out of there. J. Smith noted the dump calculations for the months of April, May, and June and the amount owed to the town of Beacon Falls for the leachate is \$18,347.

#### d. Sewer User Fee Study

There was no one here at the meeting tonight to discuss the Sewer Use Fee Study. J. Smith asked to keep this on the agenda for next meeting.

#### e. Industrial Park

J. Smith noted that the association is trying to buy it now. Also, the attorney never put the liens on the property. J. Smith asked to keep this on the agenda for next meeting.

#### 7. New Business

#### a. Firehouse Kitchen

J. Smith indicated that the firehouse submitted a waiver for the Automatic Grease Removal System due to hardship with the estimate of \$10,000 for the system. J. Weed noted that that estimate seems quite high. J. Smith tried to find out who submitted the estimate but hasn't received the information yet. J. Smith noted that it is an automatic machine that dumps it in a barrel. The bakery is vacant so that hasn't been inspected. Beacon Falls Market doesn't do any cooking, just cold cuts.

J. Smith asked to keep this on the agenda for the next meeting. J. Weed asked if WPCA has specs on the grease traps. J. Smith indicated that it depends on the type of the building, how many seats, the size of the sink, and how many inches of the sink determines how much grease will be accumulated.

#### b. Treatment Plant Monthly Report

The Treatment Plant report for July 2015 submitted for tonight's meeting was submitted and reviewed.

#### c. Budget and Payment of Bills

There were 3 grinder pumps repaired prior to the letters going out. Also, there were 3 grinder pumps repaired after the letter was sent to the homeowners.
