Application A-2001-218 O&G Restoration

Ken Faroni, O&G Industries stated that the official ceremony for the conveyance of the park by O&G to the Town of Beacon Falls will be October 22nd at 2 p.m. at the site.

Application A-2009-285 O&G Redi-Mix Concrete Plant - Railroad Avenue

Ken Faroni explained that approval has been given by the Water Pollution Control Authority to build the system and tie it into the sanitary sewer into the pump station itself. The rinse off water was to discharge into the sanitary sewer. A plan of the new system was submitted to the Commission. Photos were also submitted to the Commission. A wetlands application has been submitted. The new system eliminates the discharge to the ground. A closed loop system was developed. The rinse off water drains into trenches and rinse off water from the drums is captured. It goes into an underground tank. This water will be used for: mixing into the concrete, to rinse out the drums and pump back to the plant. Ken Faroni explained the system which will be used. Jim Galligan, Town Engineer stated he is familiar with the system.

Application A-2009-283 Alliance Circle - Lot 3

Kurt Jones, Civil One represented H.I. Stone at the meeting. An application was submitted last month. The application has been determined to be complete. Rock cuts are proposed to make a feasible site. A swale will be installed to pick up any run off of ground water to be directed to a storm water pretreatment area then to a detention basin (will handle bulk of water). Also there will be another swale to the other side to going into the storm drainage system and piped to the same facility. There will be no increase in run off. There are no wetlands on the site. Basically, storm water management and erosion control. Jim Galligan, Town Engineer has not done a review as of yet. Mr. Jones and the Commission agreed that the project should be done in three phases.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Smith to table this application until review of the sedimentation and erosion control of the wetland is reviewed and that storm water management data is reviewed by the Town Engineer.

Discussion: Vice Chairman Smith stated the board should decide on the application that was presented. It is strictly storm water management. Commissioner Minnick feels two motions will be needed with it is approved: one for Inland Wetlands and one for storm water management.

Commissioner Minnick stated if he clear cuts on a steep slope there is potential (soil and erosion into the wetlands) it is now regulated. Commissioner Minnick is requesting that the wetlands be flagged. Mr. Cote was not present at this meeting.
