The application is complete. The fee is to be determined. Pictures were presented to the board.

Chairman Smith read the following letter dated December 13, 2011 from David L. Nafis, P.E. & L.S.: "We recently reviewed the plans for the bridge repairs entitled "Emergency Improvement Plan, dated December 2, 2011, prepared NOK Associates". We feel the proposed repairs shall be adequate as a temporary solution and will have minimal impact upon the wetlands. It should be noted that the repairs are being conducted on private property. Even though we've reviewed the plans on behalf of the Town, the Town is not responsible for the lifespan or effectiveness of the repairs. In the event further problems arise, the burden for the repairs will be solely on the property owner".

Erika Reichard-Lawton, 50 Burton Road stated that the sanitary sewer and water are currently exposed. They are concerned that once it gets cold the water line will break. The work should take a week to complete.

Commissioner W. Opuszynski stated he did not want to set a precedent regarding the fees, would like to see a permanent fix and when will it be done. Vice Chairman Knapik stated it sounds like this is the permanent fix.

Commissioner Minnick his concern when it happened was the head wall and the downstream wall. This will be a structural improvement that what was originally suggested. He stated it is more of a permanent fix. The contractor is going to be digging down deep enough; it is going down below the footings and the existing wall. The concrete wall will now come into the stone structure. He does not feel it will be setting a precedent regarding the fees as long as the State fee is paid. Commissioner Minnick stated that the construction sequence as it is written is not correct. They should state that they are going to be down into the pond area, working with an antitracking pad, etc. The brook needs to be cleaned or it will work as a dam and will retain too much water. An application to this board would be needed when the pond is to be cleaned. The State fee is currently \$80.

Charles Edwards, 50 Lorraine Drive - C. Edwards Construction is the contractor. He explained the construction sequence:

- 1. A tracking pad will be installed.
- 2. Material will be cleaned out.
- 3. Install sleeves.
- 4. Pump some of the water out.
- 5. Go down to bedrock (hard base).
- 6. Divert water.
- 7. Higher elevation to direct water.
- 8. Preparation to get in there to allow construction.

Mr. Edwards stated he is trying to make the least amount of disturbance. The work should take approximately one week to two weeks maximum.







Application A-2011-290 - Ryan Smith, 80 Pines Bridge Road

David Keating, Wetlands Enforcement Officer stated that Mr. Smith has a status report and a request for amendments:

Status Report dated 10/12/2011 states:

- 1. To date the silt fence has been installed and inspected.
- 2. The front yard and parking area has been graded.
- 3. The old concrete stairs and sidewalks have been removed.
- 4. Boulders and fill were delivered to the site.
- 5. The boulders have been used to outline the new look of the western side yard and hold the fill.
- 6. The first 26' of the timber retaining wall has been shored up with boulders and fill.
- 7. Currently 40 yards of process is stockpiled on site. The process will replace the loam currently located in the parking area creating a proper base for future paving. The loam from the parking area will be used for planting bed along Rte. 42.

Proposed Amendments:

- 1. Removal of four maple trees (see attached description from Out on a Limb Tree Service). The trees have been tagged and are marked on copies of original accepted map. To lessen the impact on the wetlands the trees will be removed with the use of a crane.
- 2. Request a change of species from Yew to Juniper for proposed plantings along the guard rail on Route 42.

Mr. Smith presented a map to the board. Mr. Smith stated he wanted to take down four trees. The trees will be taken down using a crane. Mr. Smith presented pictures on his cell phone to the board. They will not be encroaching on the wetlands. The stumps will remain. Mr. Smith also explained in the original plan it showed a yew to be planted, he would like to make a change to a juniper.

Commissioner Minnick stated that since his activity is not in the wetlands or setback from the wetlands he feels a motion can be made to approve the changes.

Motion was made by Commissioner Minnick and seconded by Commissioner W. Opuszynski to approve the plan as modified.

Vice Chairman Knapik had a question about the materials which were brought in. Vice Chairman Knapik stated he is satisfied with Chairman Smith's response. He did not realize it was part of the application. The back wall was discussed.

Application A-2001-218 O&G Restoration

Chairman Smith stated that last month there was some discussion regarding Toby's Pond. Ken Faroni, O&G was asked to attend this meeting. Chairman Smith stated that there was some damage done to Toby's Pond after the storm. Commissioner Minnick stated an email was sent concerning his concerns. Mr. Faroni stated he did not get the email. The Town has some responsibilities which were neglected and O&G has some responsibilities which were neglected. Help is needed to resolve it. Mr. Faroni has gotten an email from Susan Cable.

Mr. Faroni stated that for the next 25 years after the property was deeded to the Town was to maintain the spillways and the dikes. A payment of \$40,000 was provided to the Town which is to be used for maintenance for Toby's Pond. In March after the first flood, a letter was received from Nafis & Young. Commissioner Minnick, Susan Cable, First Selectman, Jim Galligan, Town Engineer and himself met there. The boat ramp in that location is not going to work. There were reservations from the beginning. It was a requirement of DEP to put a boat ramp in. The rip rap was putted back. The boat ramp will be moved south where it will not be impacted by flood waters. Ken Faroni presented a chart to the board concerning discharge statistics. It has been designed to flood on a two year frequency. DEP did not want to see the river reroute itself to the pond permanently. It was made certain that when the flood waters receded they would revert back to a normal flow. There have been no problems with the dike. Ken Faroni explained repairs which have been done. The bridge needs to be addressed. The rip rap will be addressed. There is question as to whose responsibility it is to maintain the spillway. Metro North has done some work in this area. The boat ramp was made out of sand; it was not going to work, Commissioner Minnick mentioned armoring where the old boat ramp was. The existing materials need to come out of the pond now. More heavy armor is needed. There was no armor where the boat ramp was. Commissioner Minnick stated there was a letter sent to the Selectmen to hold off for one year before accepting Toby's Pond to see how the spillway was going to work. Repairs were done in May. The stockpiles are diverting the water, they need to be removed. The boat ramp will be built in a new location. The Japanese knotweed needs to be taken care of. The spillway needs to be cleaned up because it acts as a dam.

New Applications

Application A-2011-294 – 34 Lasky Road – Ed Zaldumbide - Addition to House
David Keating, Wetlands Enforcement Officer explained the homeowner on 34 Lasky Road needs to replace some existing sona tubes so that the structure can be redone which are within 50 feet of the wetland and watercourse. Therefore, a permit is needed from this Commission. Joe Michaud, Contractor came before the board representing the homeowner and presented the proposed plan to the board. The deck will come out 20 feet and across 45 feet. The stairs will be 27 feet from the wetlands. An addition will be built on the back of the house. There will be 12 columns, 10 inches wide, 8 inches deep with the addition on top. The addition is coming out 12 feet. The proposed deck is 20 feet wide; the addition is only 12 feet. There is a deck there currently. The new addition is going to be where the second deck is now. Mr. Michaud explained that upstream there is a three foot drain in the neighbor's yard. To the right downstream a road was built on the other side of the brook. Mr. Michaud presented pictures and a video to the board. Mr. Michaud stated that the stairs could be relocated. Chairman Smith stated the deck can be shortened. No IWWC fee was paid. Commissioner W. Opuszynski stated his concern regarding erosion control during construction. No machinery will be used to dig the holes for the tubes.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Knapik to accept the application for review and on the agenda for next month.

The property owner complained that there is an increase of the amount of water caused erosion. Dave Keating visited both properties. He also made copies of information from the building department. There is no Inland Wetland or Watercourse that has been scoured out. There is erosion. It was determined that it is a civil issue between the two property owners. Photos have been forwarded to the board. Chairman Smith contacted Jim Galligan, Town Engineer concerning this matter. Chairman Smith feels the Town Attorney should be contacted. The storm water management regulations talks about storm water runoff into town streets and town facilities, not from house to house/private property. Dave Keating will contact the town attorney.

Commissioners W. Opuszynski and M. Opuszynski are back on the board.

76 West Road - Lee Ann Rivers

Chairman Smith explained that he and Vice Chairman Knapik visited 76 West Road, Lee Ann Rivers' property. It was noted that Mr. Jones had completed his drainage work. He was tied into the storm drainage system. Chairman Smith stated that another neighbor's yard had just been reseeded. His gutters were piped and he day lighted them right toward the backyard of 76 West Road. This may not be why it was wet six months ago, this work was just done. It was visible where the water trailed through the woods. It is possible that Mr. Jones could have contributed to





Chairman Edward Smith called the Regular Meeting of the Inland Wetlands and Watercourse Commission of October 12, 2011 to order at 7:37 p.m.

Present: Chairman Edward Smith, Vice Chairman Stephen Knapik and Commissioners: Richard Minnick, Walter Opuszynski and Michael Opuszynski.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Knapik to allow the Chairman to rearrange the agenda accommodate the public.

Application A-2011-290 - Ryan Smith, 80 Pines Bridge Road

David Keating, Wetlands Enforcement Officer stated that Mr. Smith has a status report and a request for amendments:

Status Report dated 10/12/2011 states:

- 1. To date the silt fence has been installed and inspected.
- 2. The front yard and parking area has been graded.
- 3. The old concrete stairs and sidewalks have been removed.
- 4. Boulders and fill were delivered to the site.
- 5. The boulders have been used to outline the new look of the western side yard and hold the fill.
- The first 26' of the timber retaining wall has been shored up with boulders and fill.
- 7. Currently 40 yards of process is stockpiled on site. The process will replace the loam currently located in the parking area creating a proper base for future paving. The loan from the parking area will be used for planting bed along Rte. 42.

Proposed Amendments:

- 1. Removal of four maple trees (see attached description from Out on a Limb Tree Service). The trees have been tagged and are marked on copies of original accepted map. To lessen the impact on the wetlands the trees will be removed with the use of a crane.
- 2. Request a change of species from Yew to Juniper for proposed plantings along the guard rail on Route 42.

Mr. Smith presented a map to the board. Mr. Smith stated he wanted to take down four trees. The trees will be taken down using a crane. Mr. Smith presented pictures on his cell phone to the board. They will not be encroaching on the wetlands. The stumps will remain. Mr. Smith also explained in the original plan it showed a yew to be planted, he would like to make a change to a juniper.

Commissioner Minnick stated that since his activity is not in the wetlands or setback from the wetlands he feels a motion can be made to approve the changes.

Motion was made by Commissioner Minnick and seconded by Commissioner W. Opuszynski to approve the plan as modified.

Vice Chairman Knapik had a question about the materials which were brought in. Vice Chairman Knapik stated he is satisfied. He did not realize it was part of the application. The back wall was discussed.

Application A-2001-218 O&G Restoration

Chairman Smith stated that last month there was some discussion regarding Toby's Pond. Ken Faroni, O&G was asked to attend this meeting. Chairman Smith stated that there was some damage done to Toby's Pond after the storm. Commissioner Minnick stated an email was sent concerning his concerns. Mr. Faroni stated he did not get the email. The Town has some responsibilities which were neglected and O&G has some responsibilities which were neglected. Help is needed to resolve it. Mr. Faroni has gotten an email from Susan Cable.

Mr. Faroni stated that for the next 25 years after the property was deeded to the Town was to maintain the spillways and the dikes. A payment of \$40,000 was provided to the Town which is to be used for maintenance for Toby's Pond. In March after the first flood, a letter was received from Nafis & Young. Commissioner Minnick, Susan Cable, First Selectman, Jim Galligan, Town Engineer and himself met there. The boat ramp in that location is not going to work. There were reservations from the beginning. It was a requirement of DEP to put a boat ramp in. The rip rap was putted back. The boat ramp will be moved south where it will not be impacted by flood waters. Ken Faroni presented a chart to the board concerning discharge statistics. It has been designed to flood on a two year frequency. DEP did not want to see the river reroute itself to the pond permanently. It was made certain that when the flood waters receded they would revert back to a normal flow. There have been no problems with the dike. Ken Faroni explained repairs which have been done. The bridge needs to be addressed. The rip rap will be addressed. There is question as to whose responsibility it is to maintain the spillway. Metro North has done some work in this area. The boat ramp was made out of sand; it was not going to work. Commissioner Minnick mentioned armoring where the old boat ramp was. The existing materials need to come out of the pond now. More heavy armor is needed. There was no armor where the boat ramp was. Commissioner Minnick stated there was a letter sent to the Selectmen to hold off for one year before accepting Toby's Pond to see how the spillway was going to work. Repairs were done in May. The stockpiles are diverting the water, they need to be removed. The boat ramp will be built in a new location. The Japanese knotweed needs to be taken care of. The spillway needs to be cleaned up because it acts as a dam.

New Applications

Application A-2011-294 – 34 Lasky Road – Ed Zaldumbide - Addition to House
David Keating, Wetlands Enforcement Officer explained the homeowner on 34 Lasky Road
needs to replace some existing sonic tubes so that the structure can be redone which are within 50
feet of the wetland and watercourse. Therefore, a permit is needed from this Commission. Joe
Michaud, Contractor came before the board representing the homeowner and presented the
proposed plan to the board. The deck will come out 20 feet and across 45 feet. The stairs will be
27 feet from the wetlands. An addition will be built on the back of the house. There will be 12
columns, 10 inches wide, 8 inches deep with the addition on top. The addition is coming out 12
feet. The proposed deck is 20 feet wide; the addition is only 12 feet. There is a deck there
currently. The new addition is going to be where the second deck is now. Mr. Michaud explained
that upstream there is a three foot drain in the neighbor's yard. To the right downstream a road
was built on the other side of the brook. Mr. Michaud presented pictures and a video to the board.
Mr. Michaud stated that the stairs could be relocated. Chairman Smith stated the deck can be
shortened. No IWWC fee was paid. Commissioner W. Opuszynski stated his concern regarding
erosion control during construction. No machinery will be used to dig the holes for the tubes.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Knapik to accept the application for review and on the agenda for next month.

3 Sharon Drive - drainage

David Keating, Wetlands Enforcement Officer explained a letter was received last month from the property owner of Cooke Lane regarding 3 Sharon Drive. The property owner complained that there is an increase of the amount of water caused erosion. Dave Keating visited both properties. He also made copies of information from the building department. There is no Inland Wetland or Watercourse that has been scoured out. There is erosion. It was determined that it is a civil issue between the two property owners. Photos have been forwarded to the board. Chairman Smith contacted Jim Galligan, Town Engineer concerning this matter. Chairman Smith feels the Town Attorney should be contacted. The storm water management regulations talks about storm water runoff into town streets and town facilities, not from house to house/private property. Dave Keating will contact the town attorney.

Commissioners W. Opuszynski and M. Opuszynski are back on the board.

76 West Road - Lee Ann Rivers

Chairman Smith explained that he and Vice Chairman Knapik visited 76 West Road, Lee Ann Rivers' property. It was noted that Mr. Jones had completed his drainage work. He was tied into the storm drainage system. Chairman Smith stated that another neighbor's yard had just been reseeded. His gutters were piped and he day lighted them right toward the backyard of 76 West Road. This may not be why it was wet six months ago, this work was just done. It was visible where the water trailed through the woods. It is possible that Mr. Jones could have contributed to the runoff. Mr. Jones is now tied into the storm sewer. Mrs. Rivers has been contacted. Commissioner Minnick explained we have had a significant amount of rain that is not normal.



Appendixes C, D, E, F, G, H: ordinance concerning the designation of the IWWC as the town aquifer. A PDF copy is needed to provide it to Larry Secor to include in the regulations when it is published. Contact person Karen Wilson.

Ordinance – Establishing Criteria for Procedures and Finds – should refer to it and added as Appendix I. Section 14 – it is referenced on page 27, it is different from what is in the document.

Page 7-3.1 – Inventory of Regulated Areas – Paragraph One – states 50 foot, should it be changed to 100 foot? Is the correct word – regulated? What should verbage be? Within 100 feet is regulated. All areas within 50 feet of any wetlands or watercourses are regulated areas. Any areas within 100 feet are considered review areas. Change 50 feet to 100 feet.

Bottom of page file name - keep name of the document on bottom of page and date adopted.

Page 8 - Item G - 42.C - some of the changes from Darcy Winters result of a town's wetlands commission suing the town fire department.

Page 15 - 7.10 - a and b - how long permits are valid.

Page 27 – 14.6 & 14.7 – should reference the ordinance and what appendix (I) and verbage. Item 14.7 needs to go to Selectmen and a Town Public Hearing before vote. Another Item as 14.8 needed – other enforcements to include.

Page 33 - 19.7 - Fee Schedule - Applications Fee shall be based on town ordinance and refer back to Index - Appendix G. On Appendix G - not what the ordinance is called.

Return Receipts when holding a Public Hearing - checked with DEEP and Town Attorney. State Statute reads - may request, not must. IWWC will continue to request return receipts.

Chairman Smith asked three times if there were any more questions or comments concerning the proposed regulations?





Chairman Edward Smith called the Regular Meeting of the Inland Wetlands and Watercourse Commission of August 10, 2011 to order at 7:30 p.m.

Present: Chairman Edward Smith, Vice Chairman Stephen Knapik and Commissioners: Richard Minnick, Walter Opuszynski and Arlene Brumer.

Also Present: Wetlands Enforcement Officer David Keating, Lee Anne Rivers, 76 West Road, Harold Jones, 2 Wanda Drive and Lars Edgren, 180 Lasky Road.

Pledge of Allegiance - recited

Comments from the Public

Lee Anne Rivers, 76 West Road came before the board concerning drainage coming onto her property. Brian Herb called Chairman Smith on Monday regarding drainage that was being put in on private property tieing into a storm drain on private property, a couple of manholes that were put in. The catch basins were being tied into the West Road storm water system. Mrs. Rivers explained that she has a neighbor up on the hill above her and over the past few years, her yard became constantly wet. They cannot walk on the bank up her hill, because you sink in mud. Mrs. Rivers stated that her driveway turns into ice in the winter and is a mess. She is also losing trees on her tree line possibly root rot. Chairman Smith stated that this is a storm water management problem and would have to visit the site. Mrs. Rivers stated that her neighbor's front yard was recently dug up.

Harold Jones, 2 Wanda Drive came before the board and stated that he installed catch basins and manholes on his property. Mr. Jones presented a map to the board. Mr. Jones stated during the hurricane he had water in his cellar. He stated his curtain drains were plugged up. Chairman Smith asked if any of surface water is coming down to Mrs. Rivers's property. Mr. Jones stated that he excavated his property where the water comes down and tied into the manhole. Chairman Smith stated they will do a field walk.

Lars Edgren of 180 Lasky Road came before the board concerning drainage from Route 42 onto his driveway. Vice Chairman Knapik visited the site and can see where the water is coming from. Chairman Smith stated that a Cease and Desist Order was issued by the Zoning Enforcement Officer regarding 177 Lasky Road to clean up the property. Vice Chairman Knapik stated that the storm pipe was installed on Route 42 and it is not working like it used to. 



I, Commissioner Richard Minnick, this date August 10, 2011, make a motion to approve the application for a Medical Office Building, Lot #45 Industrial/Business development located on 127 Pines Bridge Road, in Beacon Falls, Connecticut, application number A-2011-291, based on substantial evidence heard at the public hearing presented by the Applicant, JLN Consulting, George Logan, James Cassidy, the Beacon Falls Inland Wetlands and Watercourse Commission, (Commission), Commission Staff including the Town's Engineer, Administrative/Enforcement Officer, Commission Members, the Public, and others, during the course of the proceedings, that the Commission grant the application whereas, finding that there are no prudent and feasible alternatives to those presented and such activity shall have minimal impact on the wetlands and watercourses providing that the plans are implemented as presented and approved.

- 2. This permit is not transferable without prior, written consent of the Beacon Falls Inland Wetlands and Watercourse Commission. If transfer is approved by the Commission, the terms and conditions of this permit shall bind all successors, heirs and/or assigns of the Applicant.
- 3. The Commission reserves the right to suspend or revoke the permit for due cause and in accordance with the procedures of the Connecticut General Statutes, Section 22a 42a (d).
- 4. Any minor revisions to the documents identified in paragraph 1 above shall be submitted to the Town Engineer, the Commission's Administrative Enforcement Officer, and one (1) of the following members of the Beacon Falls Inland Wetland and Watercourse Commission for review. Chairperson, Vice-Chairperson, or the Secretary. The decision as to whether a change is minor will be made by the Commission member to whom the proposed revisions are submitted. The decision as to whether to approve proposed minor revisions or to deny proposed revisions as substantial in nature shall be at the discretion of that Commissioner. Changes which are deemed by that Commissioner to be substantial in nature will require submission to and review by the

entire Commission in accordance with Section 7.8 of the Inland Wetland and Watercourse Regulations of the Town of Beacon Falls. Any increase in the extent of regrading, development, disturbance, or impacts within or to the wetlands or watercourses, or in the regulated areas around the wetlands or watercourses, i.e., the fifty (50) feet setbacks, will require prior submission to and review by the entire Commission in accordance with Section 7.8 of the Inland Wetland and Watercourse regulations of the Town of Beacon Falls.

- 5. The <u>Record Subdivision Map</u> shall have a Signature Block for approval by the Beacon Falls Inlands Wetlands Commission.
- 6. All wetlands and watercourse areas shall be designated by markers provided by the Commission to the Applicant to be placed and secured to the appropriate tree or post prior to commencement of any work activity. The Applicant, will provide a <u>marked</u> print indicating the location of the markers. A copy of the print will be kept on file with the Commission.
- 7. The <u>Record Subdivision Map</u> shall designate the wetlands and watercourses as well as the fifty (50) foot regulated buffer. A note is to be added to the <u>Record Subdivision Map</u> indicating that no activity is to be conducted in the buffer area without a permit from the Commission.
- 8. The <u>Record Subdivision Map</u> shall have a note indicating that no underground fuel storage tanks are permitted.
- 9. A sediment and erosion control and detention area <u>line of credit</u> and/or <u>cash</u> in the amount of Twenty Five Thousand dollars (\$25,000.00) must be submitted to the Inland Wetlands and Watercourse Commission prior to any disturbance or excavation work-taking place in connection with this project. The excavation work taking place in connection with this project for the construction of the detention area these funds will not be released to the Applicant until completion of the entire project. The performance bond and surety shall be in a form that is immediately accessible to the Town upon the failure of the developer to properly install or maintain appropriate and necessary sediment and erosion controls. If the Commission is forced to use any or all of the line of credit and/or cash amount for erosion and sediment control measures, the permit to the developer shall be suspended and may not be reactivated until after a hearing is conducted by the Commission and the full line of credit and/or cash amount is restored and the developer clearly demonstrates to the Commission's satisfaction that all sediment and erosion control measures can and will be properly maintained in the future.
- 10. During the construction of the roads, water channels, drainage system and utilities, written reports from the Applicant shall be submitted to the Commission each month. The reports must be received at or prior to the regularly scheduled meeting on the second Wednesday of each month. The reports shall be detailed and shall review all work undertaken at the site including, but not limited to:
 - Types and amounts of materials moved on and/or removed from site;
 - Types of materials brought to the site;
 - Sources and content of material brought to the site;
 - Extent and locations of grading, filling, excavation and other changes to the site;
 - Seeding, planting, transplanting and other efforts to create and/or restore vegetative cover:
 - Sediment/erosion/siltation and other control measures used on site, how effectively
 those controls are functioning, and what controls can or will be installed within the
 next thirty (30) days to control activities and conditions at anticipated work areas;

- The Commission may require other information as appropriate and/or necessary.
- 11. The Applicant is responsible for obtaining any and all additional permits and approvals necessary to complete the project. The permit from the Beacon Falls Inland Wetlands and Watercourses Commission concerns only the work within and adjacent to regulated areas and the storm water detention system and sediment and erosion control plan necessary for the implementation of the project. The Commission advises the Applicant that approval must be obtained from other local departments and commissions and a water diversion or dam permit might be necessary from the CT Department of Environmental Protection. The Applicant shall provide to the Commission a copy of such permits or, written confirmation that such approvals are not necessary.
- 12. The Applicant shall verbally notify the Town Engineer and also shall notify the Wetland Enforcement Officer and or Chairperson in writing no less than ten (10) days prior to the commencement of construction and/or excavation and/or other disturbance activities at the site. The Staff will inspect the erosion controls to make sure that they are sufficient and as per plan. All sediment and erosion control measures should be maintained until all disturbed areas are stabilized and re-vegetated.
- 13. To deal with the on-site conditions and to prevent degradation of/and negative impact to wetlands and/or watercourses, the Applicant shall use sediment/erosion controls and environmental protection measures shown on the plans, in the application, and per the Standards as set forth in "2002 Connecticut Guidelines for Soil Erosion and Sedimentation Control" handbook. The Applicant shall also use any additional controls and/or measures as may be required by the BFIWWC Enforcement Officer, the Town Engineer or other appointee of the Commission.
- 14. All field changes deviating from the approved plans must be submitted by the Applicant to the Town Engineer before any such changes are implemented. If the Town Engineer determines that the field changes are minor in nature, and will not permanently impact the wetlands, watercourses, the wetlands and watercourses set-back areas, other areas regulated by the Commission, or the storm detention system, then the Town Engineer may approve the proposed field changes. If the proposed field changes are substantial, as determined by the Town Engineer, or if they could result in permanent impacts to the wetlands, watercourses, setback areas or regulated areas, or if they involve the storm detention system, then the proposed field changes must be submitted to the entire Commission pursuant to Section 7.8 of the regulations of the Commission. Such modifications due to field conditions cannot be implemented unless and until approved by the Commission.
- 15. No equipment or material, including without limitation, fill, construction materials, debris, or other items shall be deposited, placed or stored in any wetland or watercourse on or off site unless specifically authorized by this permit.
- 16. Extra sediment/erosion controls (fencing, stone, etc.) shall be stored on site and in immediately accessible areas to deal with unforeseen circumstances and emergencies.
- 17. During inclement weather and at the end of each day, or when work is discontinued for any other reason, the site must be secured and safe. All necessary and appropriate sediment and erosion controls are to be in place and functional at the end of each day.
- 18. Adequate precautions and safeguards shall be undertaken by the Applicant whenever heavy rains or high water flow are predicted. These precautions and safeguards include, but are not limited to:

- a. Securing and reinforcing all sediment/erosion/siltation control measures;
- b. Properly protecting or removing from harms way any stock piled material that may erode;
- c. Removing machinery from low areas subject to flooding; and
- d. Any other measures as may be necessary.
- 19. This permit is being authorized for a period of five (5) years and shall expire on August 10, 2016. It is understood that the project may take longer to complete, depending on market conditions. If the project is proceeding in accordance with the approved plans and applicable stipulations and conditions; and problems, difficulties and unforeseen circumstances have been promptly corrected and addressed by the Applicant, then the Commission may extend the permit in increments of one (1) year to a maximum total of five (5) years (not to exceed August 10, 2021.) pursuant to Section 22a 42a (d) of the Connecticut General Statutes.



Application A-2004-248 & 255 Chatfield Farms Active Adult Dev.

Mr. Elliott Fuller, 45 Chatfield Farms came before the board representing Chatfield Farms Community Association, Inc. On August 3, 2011 Albert Tornatore, President of Chatfield Farms Community Association, Inc. forwarded a letter requesting an amendment concerning the Notice of Deficiency dated April 25, 2011 from Jim Galligan, Town Engineer. The letter states that the storm manhole cover noted in item #9 of the Notice of Deficiency has continued to be dislodged after each significant rainfall. Residents monitoring this issue have also observed that the detention basin #160, which is part of the same drainage system as the item #9 manhole, nearly overtops during the same rain events. It is in the opinion of one of our residents, who is a licensed professional engineer, that the drainage system between the detention pond and the level spreader is compromised causing water pressure in the system to dislodge the cover. Once the cover is ajar, storm water crupts out of the manhole and then runs downhill eroding the slope which in turn is causing silt and debris to migrate towards the wetlands below. Before the wetlands and adjoining roadway (Chatfield Drive) are compromised further, I ask that the commission authorize the Town Engineer or his representative to investigate this matter and amend the Notice of Deficiency accordingly. A contractor is making preparation to address all the items in the original notice. Jim Galligan, Town Engineer stated he has discussed this matter with Mr. Fuller a couple of times. It appears that there is a blockage in the line which causes a manhole overflow

and there is backing up in the detention basin. The level spreader was discussed. There could also be construction debris in the line. Commissioner Minnick stated it is both a storm water management issue as well as a wetland issue. Because it is overflowing it is causing erosion into the pond area. Jim Galligan, Town Engineer stated he will amend the Notice of Deficiency.

New Business

Application A-2011-293 Harmon Family – 53 Habbell Avenue – Replacement Trailer David Keating, Wetlands Enforcement Officer forwarded the application to the board for a replacement of the existing house trailer that has been damaged. A replacement trailer of the same size and in the same location will be put in. The trailer is within the regulated area adjacent to the Naugatuck River. The maps, plans and application fee of \$110.00 have also been received. Gary Giordano, Professional Engineer and Licensed Land Surveyor, LLC represented John Harmon. Mr. Giordano explained that the existing house trailer was damaged by a storm and the owner would like to replace it in the same place and same size. The current trailer is within the 100 foot buffer area. Silt fencing will be installed during the replacement. Jim Galligan, Town Engineer stated that it is outside the flood plain and there are no engineering issues. Barbara Kenney, daughter of John Harmon submitted pictures of the trailer and land to the commission. There will not be any grading or disturbance.

Application A-2011-292 - Downtown Streetscape

Doron Dagan, P.E., of Luchs Consulting Engineers came before the board concerning the Beacon Falls Streetscape. Mr. Dagan explained the project is 1,800 linear feet of streetscape. The southbound right lane on Main Street will be converted into a five foot greenway which will consist of trees and ornamental lighting and a ten foot walkway which will overlook the river. There will be timber guardrails and one outlook platform. There will be another potential area for another outlook. One storm water outfall will be cleaned and there are no new outfalls proposed. All the sumps of the catch basins will also be cleaned. The wetland has been flagged. Extra hay bales will be held and silt fence will be put in place. Permits had to be obtained from DEP. In order to conform to their requirements the second outlook cannot be built at the present time.

Commissioner Minnick asked that a record of permits be forwarded to the commission. Fred Clark, Consulting Engineer, stated that the project is not under jurisdiction of the Army Corps. The DEP does have jurisdiction over both stream channel encroachment line and the one hundred

year flood line. To avoid one year permitting and excessive fees, they modified the design to be within the DEP and DOT guidelines. The project can go to bid, The documentation from the DEP stating the project can go to bid will be forwarded to the commission. The project should be completed by the end of the summer. There will be a 12 foot travel, a four foot shoulder, a foot snow shelf beyond and then the walkway. Trees will be thinned or pruned and some removed.

Jim Galligan, Town Engineer has a couple of matters which need to be clarified as to the storm water management.

Vice Chairman Knapik questioned as to how storm water management got to a zero net increase in peak flow. Chairman Smith explained that they still have to get a storm water management permit from the commission. Unless they reach the zero net increase, there is no construction permit.

Chairman Minnick made the general statement for discussion and he would make a motion to include in an approval in accordance with the standard conditions, i.e. pre construction meeting, surety bond in place and determined by staff, silt fences installed, marking of the wetlands, specific on the maintenance of separators and detention pond, as of plans revised on 8/4/11. Detail on the invasive species mitigation and out of kind restoration of the wetlands. Chairman Smith stated this motion will be strictly concerning the wetlands.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Knapik to approve Application A-2011-291 127 Pines Bridge Road - Lot #45 - Dr. Dey after review and information of the public hearing that there are no prudential and feasible alternatives to this application that included are the standard conditions of approval which includes revised plans dated 8/4/11. Additional information required: A schedule of maintenance of the separators and detention pond within the review area, a detail of the invasive plant species mitigation and out of kind wetlands planting in the mitigation area.



Application A-2004-248 & 255 Chatfield Farms Active Adult Dev.

Mr. Elliott Fuller, 45 Chatfield Farms came before the board representing Chatfield Farms Community Association, Inc. On August 3, 2011 Albert Tornatore, President of Chatfield Farms Community Association, Inc. forwarded a letter requesting an amendment concerning the Notice of Deficiency dated April 25, 2011 from Jim Galligan, Town Engineer. The letter states that the storm manhole cover noted in item #9 of the Notice of Deficiency has continued to be dislodged after each significant rainfall. Residents monitoring this issue have also observed that the detention basin #160, which is part of the same drainage system as the item #9 manhole, nearly overtops during the same rain events. It is in the opinion of one of our residents, who is a licensed professional engineer, that the drainage system between the detention pond and the level spreader is compromised causing water pressure in the system to dislodge the cover. Once the cover is ajar, storm water crupts out of the manhole and then runs downhill eroding the slope which in turn is causing silt and debris to migrate towards the wetlands below. Before the wetlands and adjoining roadway (Chatfield Drive) are compromised further. I ask that the commission authorize the Town Engineer or his representative to investigate this matter and amend the Notice of Deficiency accordingly. A contractor is making preparation to address all the items in the original notice. Jim Galligan, Town Engineer stated he has discussed this matter with Mr. Fuller a couple of times. It appears that there is a blockage in the line which causes a manhole overflow and there is backing up in the detention basin. The level spreader was discussed. There could also be construction debris in the line. Commissioner Minnick stated it is both a storm water



Chairman Edward Smith called the Public Hearing of the Inland Wetlands and Watercourse Commission of August 10, 2011 to order at 7:05 p.m.

Present: Chairman Edward Smith, Vice Chairman Stephen Knapik and Commissioners: Richard Minnick, Michael Opuszynski and Arlene Brumer.

Also Present: Wetlands Enforcement Officer David Keating, James Galligan, Town Engineer, Jack Neubieser, George Logan and Public.

The following notice was read by the Clerk: Notice is hereby given that the Town of Beacon Falls, Inland Wetlands & Watercourse Commission will hold a Public Hearing on Wednesday, August 10, 2011 at 7:00 p.m. at the Beacon Falls Town Hall, Assembly Room, 10 Maple Avenue, Beacon Falls, CT. concerning: Application A-2011-291 — Pines Bridge Road/Lot #45 — Dr. Dey. At this hearing, interested persons may appear and/or written comments may be submitted. The copy of the application is on file at the Town Clerk's Office, 10 Maple Avenue, Beacon Falls, CT Edward J. Smith, Chairman. Published in the Waterbury Republican American - Thursday July 28, 2011 and Thursday, August 4, 2011.

Jack Neubieser presented the return receipt notices from adjoining property owners to the board. Mr. Neubieser stated that this project is for Dr. Dey on Pines Bridge Road/Lot #45. The proposal is for a 4,950 foot medical office building at 127 Pines Bridge Road. It is the current home of the Lafferty Family. The proposed office building will tie into the sanitary sewer, water, gas, electrical and telephone. The wetlands were flagged by George Logan, Certified Soil Scientist. The project includes 3,280 square feet of wetlands disturbance. Jim Galligan, Town Engineer has been reviewing the project with Jim Cassidy, Project Engineer. As of this time, all of the concerns of the Town Engineer have been addressed. There is still some discussion concerning the method of water management. Zero increase run off from site needs to be satisfied.

George Logan, Certified Soil Scientist, REMA Ecological Services submitted a report dated July 25, 2011. The report details wetlands on the property, the potential impacts and mitigation. The property has approximately .86 acres of wetlands. Mr. Logan pointed out the wetlands on the proposed site map. There is a watercourse on the western side that eventually drains to the collection system in the road. The wetlands were flagged on April 16, 2011. Mr. Logan's associate visited the site on May 23, 2011 to inventory the vegetation. Mr. Logan visited the site on July 20, 2011. The soils on the site of wetlands are outwash materials — sand and gravel. The back side is dense hard pan till. There is poorly drained soil. At the toe of the slope towards the neighbors in the back, there is significant discharge that happens there throughout a significant portion of the growing season. The wetlands are saturated in the fall season. There are a couple of

areas where it would be flooded, mostly an artificial condition because of the filling of the wetland that has happened in the past.

Groundwater discharge is a principal wetland function, particularly the upper (southern) portion. The hydro-geologic classification of this wetland is for the most part groundwater slope, while the dominant hydrologic regimes are seasonally saturated and seasonally flooded. The wetlands is not highly functioning, probably average or below average for most functions. There are tires and evidence of disturbance on the site. In the westerly area there is more disturbance looking into the wetland. There is dobris and other materials on site. The nicest portion of the wetland is in the middle where most of the discharge is happening.

Red maples are dominant species, the under story moderately dense. There is arrow wood, a type of blueberry, winterberry and the usual species that are found in a red maple swamp. There is some skunk cabbage. There is invasive species throughout the wetlands — multi-flora rose. There is Japanese knotweed present in the central portion of the wetlands.

The total wetland disturbance is 3,280 square feet. Approximately 565 square feet of wetland habitat would be created within the proposed stormwater quality basin. The invasive species would be removed. Then wetlands type shrubs or similar to the ones that are there will be planted. The professional opinion is that with appropriate mitigation measures, adverse impacts to the wetland system on this property will not be significant. The stormwater management elements are incorporated into the plan which includes: water quality basin, separators and sump catch basins. The property is surrounded on three sides by residential development and industrial development across the street.

Commissioner Minnick questioned the water inflow to the property. Mr. Logan explained that there are several areas of surface run off from the properties in the area. There is stormwater discharge at the edge of the wetland. The watershed divide was discussed. Groundwater discharge was discussed. Wildlife in this area would consist of possums and skunks and an occasional coyote. There is still a vegetative forested area that remains enough for those species to be able to traverse through.

Commissioner M. Opuszynski inquired as to the total amount of wetlands that would be affected. Specifically, the regulated upland review area activity number one. Mr. Logan explained that there are two types of activity: activity in the wetland itself (actually filling) and then activities within the upland review areas (zone – 50 feet which goes from the edge of the wetland in an upland direction). This is the zone which the commission is very careful to look at, the activities that are happening in the upland review area. Commissioner Opuszynski inquired as to the erosion control plan.

Commissioner Minnick questioned the maintenance of the stormwater management system. In the plans, there were no specifics of the frequency of cleaning and/or maintenance. There was no proposed maintenance schedule in there. The Town Engineer has specifics. Mr. Logan mentioned the Best Management Practices and other requirements by the Town Engineer.

The engineer has to be satisfied that the project engineer has done the method correct to prove that there is not going to be an increase in discharge. If calculated correctly, there will be no increase in peak discharge.

Chairman Smith asked three times if anybody else would like to favor or against this application. Chairman Smith asked if any member of the board or staff had any more questions.

Motion was made at 7:50 p.m. by Commissioner Minnick and seconded by Commissioner Brummer to close the public hearing.

At this hearing, interested persons may appear and/or written comments may be submitted. The copy of the application is on file at the Town Clerk's Office, 10 Maple Avenue, Beacon Falls, CT Edward J. Smith, Chairman, Republican American - Thursday July 28, 2011 and Thursday, August 4, 2011.

Jack Neubieser presented the return receipt notices from adjoining property owners to the board. Mr. Neubieser stated that this project is for Dr. Dey on Pines Bridge Road/Lot #45. The proposal is for a 4,950 foot medical office building at 127 Pines Bridge Road. It is the current home of the Lafferty Family. The proposed office building will tie into the sanitary sewer, water, gas, electrical and telephone. The wetlands were flagged by George Logan, Certified Soil Scientist. The project includes 3,280 square feet of wetlands disturbance. Jim Galligan, Town Engineer has been reviewing the project with Jim Cassidy, Project Engineer. As of this time, all of the concerns of the Town Engineer have been addressed. There is still some discussion concerning the methodology of water development. Zero increase run off from site needs to be satisfied.

George Logan, Certified Soil Scientist, REMA Ecological Services submitted a report dated July 25, 2011. The report details wetlands on the property, the potential impacts and mitigation. The property has approximately .86 acres of wetlands. Mr. Logan pointed out the wetlands on the proposed site map. There is a watercourse on the western side that eventually drains to the collection system in the road. The wetlands were flagged on April 16, 2011. Mr. Logan's associate visited the site on May 23, 2011 to inventory the vegetation. Mr. Logan visited the site on July 20, 2011. The soils on the site of wetlands are outwash materials - sand and gravel. The back side is dense hard pan till. There is poorly drained soil. At the toe of the slope towards the neighbors in the back, there is significant discharge that happens there throughout a significant portion of the growing season. The wetlands are saturated in the fall season. There are a couple of

areas where it would be flooded, mostly an artificial condition because of the filling of the wetland that has happened in the past.

Groundwater discharge is a principal wetland function, particularly the upper (southern) portion. The hydro-geologic classification of this wetland is for the most part groundwater slope, while the dominant hydrologic regimes are seasonally saturated and seasonally flooded. The wetlands is not highly functioning, probably average or below average for most functions. There are tires and evidence of disturbance on the site. In the westerly area there is more disturbance looking into the wetland. There is debris and other materials on site. The nicest portion of the wetland is in the middle where most of the discharge is happening.

Red maples are dominant species, the under story moderately dense. There is arrow wood, a type of blueberry, winterberry and the usual species that are found in a red maple swamp. There is some skunk cabbage. There is invasive species throughout the wetlands — multi-flora rose. There is Japanese knotweed present in the central portion of the wetlands.

The total disturbance is 3,280 square feet. Approximately 565 square feet of wetland habitat would be created within the proposed stormwater quality basin. The invasive species would be removed. Then wetlands type shrubs or similar to the ones that are there will be planted. The professional opinion is that with appropriate mitigation measures, adverse impacts to the wetland system on this property will not be significant. The stormwater management elements are incorporated into the plan which includes: water quality basin, separators and sump catch basins. The property is surrounded on three sides by residential development and industrial development across the street.

Commissioner Minnick questioned the water inflow to the property. Mr. Logan explained that there are several areas of surface run off from the properties in the area. There is stormwater discharge at the edge of the wetland. The watershed divide was discussed. Groundwater discharge was discussed. Wildlife in this area would consist of possums and skunks and an occasional coyote. There is still a vegetative forested area that remains enough for those species to be able to traverse through.

Commissioner M. Opuszynski inquired as to the total amount of wetlands that would be affected. Specifically, the regulated upland review area activity number one. Mr. Logan explained that there are two types of activity: activity in the wetland itself (actually filling) and then activities within the upland review areas (zone – 50 feet which goes from the edge of the wetland in an upland direction). This is the zone which the commission is very careful to look at, the activities that are happening in the upland review area. Commissioner Opuszynski inquired as to the erosion control plan.

Commissioner Minnick questioned the maintenance of the stormwater management system. In the plans, there were no specifics of the frequency of cleaning and/or maintenance. There was no proposed maintenance schedule in there. The Town Engineer has specifics. Mr. Logan mentioned the Best Management Practices and other requirements by the Town Engineer.







Chairman Smith noted that there will be a discussion concerning Application A-2011-291 -127 Pines Bridge Road/Lot #45 - Dr. Dev.

Motion was made by Commissioner Minnick and seconded by Commissioner Brumer to add to the agenda the Downtown Streetscape.

Jack Neubieser, JLN Consulting, James Cassidy, Hallisey, Pearson and Cassidy and George Logan, Soil Scientist and Soils Engineer represented Dr. Dey.

Jack Neubieser stated that at the last meeting there were some questions concerning the impact of the Wetlands. George Logan has mapped out and flagged the wetlands. Jim Cassidy stated that the proposal is for a 5,000 square foot medical office building. The proposal is also to build a 42 space parking lot. There are a lot of wetlands on the site. For the development of the parking and the grading on a corner of the building, there will be direct impact into the wetlands. At a corner of the building, there will be 520 square feet of direct impact into the wetlands and for the construction of the parking lot there will be a direct impact of 3,260 square feet. A storm water pond will be constructed on the site. The pond will act two fold: area of mitigation to the wetlands which will be disturbed and to clean the water that comes off the parking lot before it discharges back into the wetlands and offers some storm water retention. Another catch basin will be installed in another corner of the site which will pick up a small area of the parking lot. It is a storm water quality unit or a separator which will purify the water before it is discharged into the wetlands on the northwesterly side of the property. As there were concerns about drainage calculations, copies of the storm water management report and drainage calculations were submitted to the board. The report includes the design for the all pipes on the site and also has all the routings of two - 100 year storm events. There will be a zero increase in run off. Two parking

spaces have been removed. The disturbance is brought down to 2,760 square feet a reduction of 500 feet of direct wetlands impact. The copies of the revised plans were submitted to the board.

George Logan, Soil Scientist and Soils Engineer, of REMA made a presentation concerning the wetlands. Mr. Logan stated that he delineated the wetlands on a rainy day in April. There is roughly 0.86 acres of wetlands. In the areas that slope there is compact till. The flat area is an outwash soil. When there is compact till which goes into an outwash area it is a very wet area. The back area a few days ago was saturated. There is a groundwater slope wetland with a slight pitch. It is a wood swamp. Mr. Logan discussed the vegetation on the site. There is a good diversity of herbaceous material. There is very poor habitant quality in the upland review area which limits both wildlife habitat function and potential aesthetic value at this particular site. The wetland in the perimeter of the existing site; there have been disturbances in the past. There are infestations of Japanese knotweed. Another target species, which is spreading slowly, because of the shade, is multiflora rose. Specific protocols and procedures for eradication/control of the invasive species at the site's wetlands can be developed. It will include replanting with shrubs and herbaceous hydrophytes.

Chairman Smith stated that application has been submitted. The drainage calculations and the revised plans have been received. The application was complete for processing.

Mr. Cassidy stated that the wetlands which are being filled are not pristine wetlands. They are already filled with debris. Commissioner Minnick stated that the applicant needs to get a copy of the drainage calculations and revised maps to Jim Galligan, Town Engineer.

Motion was made by Commissioner Minnick and seconded by Vice Chairman Knapik that after reviewing the site, the application could have a significant impact on the wetlands and adjoining watercourses. A public hearing be held at 7:00 p.m. on August 10, 2011.





New Applications

Application A-2011-291 127 Pines Bridge Road/Lot #45 - Dr. Dey

David Keating, Wetlands Enforcement Officer explained that Dr. Dey's consult submitted an application for Pines Bridge Road including the fee of \$200.00/\$60.00 for the State of Connecticut, Some of the work is proposed in the wetlands – 3,780 square feet is to be filled. The application fee would be an additional \$11,340 in accordance with the fee schedule adopted by the Board of Selectmen. There is a provision in the wetlands regulations that the commission can reduce the application fee.

Chairman Smith explained that the application was received last week. Jack Neubieser, JLN Consulting and Jim Cassidy, Hallisey, Pearson and Cassidy represented Dr. Dey. Jack Neubieser explained that the project being proposed is for the construction of a 5,000 square foot medical office at 127 Pines Bridge Road for Dr. Dev. The project was previously proposed at 36 Lancaster Drive in the Industrial Park. As the State of Connecticut purchased land for fire training, Dr. Dey decided not to purchase that site and purchased another parcel of land. There was another proposal for another parcel of land but that was not a good proposal. The property is currently zoned residential; there is a zone change application before Planning and Zoning. There is a Public Hearing scheduled for August 16th. Mr. Neubieser noted a letter dated July 12, 2011 from Atty. Steven Byrne. Jim Cassidy presented the plans to the board. He explained that they are seeking a wetlands permit to work in the wetlands area. The site consists of 1.77 acres. There is an existing house and shed on the property. There are abutting residents. The wetlands have been delineated by a soil scientist. Fifty percent of the wetlands on the proposed site are in moderate to

steep locations. There is a swamp, red maples and invasive species. The proposed 5,000 square foot office building will be in the center of the property away from the wetlands. There will be a total of 42 parking spaces in the front and to the side of the building. The building will be serviced by public water and sewer. There will be some impact to the wetlands, filling for the parking lot. There will clearing of vegetation and trees. The proposed activity will be approximately 3,260 square feet in the wetlands with the filling of 151 cubic yards of material. There will be access of 20 feet around the building. In the corner there are wetlands of approximately 520 feet with the filling of 16 cubic yards of material. There will be vegetation removed and regrading will be done. The drainage in the parking lot will go to catch basins. Half of drainage goes to the east to three catch basins. Small portion of drainage goes to the west. The water quality to the wetlands will be improved. The wetlands will be replanted. Debris on the site will be removed, invasive species will be removed. The back portion of the site will be cleaned of debris and invasive species will be removed. A pond of 565 square feet will be constructed on the site. The 565 square feet of wetlands material which will be removed will be stockpiled and reused on the site.

Commissioner W. Opuszynski questioned the increase in flow. There will be a very slight increase in flow to the basin. A "v" neck will be used to regulate the flow. There will be a maintenance program for the basin. A snow shelf will be left on site. Any sand and salt will not go to the wetlands. The flow calculations are needed and a copy is to be forwarded to the Town Engineer for review. The wetland on the back of the lot will be defined. Chairman Smith mentioned that something should be put on the record that it is a wetland to discourage the neighbor from dumping debris. The fee is still to be calculated. The soil scientist report is also needed. Jim Galligan, Town Engineer has not reviewed the proposed plans. The application will be reviewed. A special meeting will be held to schedule a public hearing.







Dave Kenting, Wetlands Enforcement Officer stated that he has received an application form, maps, plans and application fee in the amount of \$110.00 from Ryan Smith, 80 Pinesbridge Road. Vice Chairman Knapik asked why are they not taking the wall down and as it is going to rot. Mr. Giordano stated that the wall is pressure treated lumber. 

Jack Neubieser, JLN Consulting, 276 Percival Avenue, Berlin, CT came before the board concerning 127 Pines bridge Road Lots 7, 8 and 12 which is currently owned by the Lafferty Family. There is currently a house and small barn structure on the property. A copy of the soil scientist report from George T. Logan, REMA is on file. The property has a fair amount of wetlands on it. Mr. Neubieser presented the Preliminary Zoning Improvement Location Survey/Site Layout Plan prepared by Halliey, Person and Cassidy dated April 26, 2011. Because of the amount of wetlands, the proposed building has to be pulled forward. A variance and zoning change will be needed if they decide to proceed with the project. The wetlands encroachment will be approximately 3,000 square feet, Mr. Neubieser noted a small proposed mitigation area in the front of the property. Mr. George Logan, REMA walked the property. Copies of the pictures of the site were forwarded to the board. The area proposed for filling is not a very high quality wetland. The back portion is of a better quality which is not proposed for any work in there. One more field trip will be made to the site to look at the plant life and growth. The site's wetland has seen significant disturbance in the past including some filling along its north edge, some dumping in various spots and ditching. For the most part, these are disturbed wetland areas. The wetlands have been flagged. David Keating, Wetlands Enforcement Officer asked how many square feet of wetlands are on the site and how many would be impacted. Mr. Neubieser stated that 3,000 square feet will be disturbed. The property is approximately 1.89 acres. There is no vernal pool on the site. Storm water management was discussed. Commissioner Minnick stated that the storm water has to be handled without disturbing more of the wetlands. It should also be noted that there is no hazardous material on the property. 





A copy of the letter is on file. The five invasive plants were identified as: Japanese stilt grass, autumn olive, Japanese barberry, multiflora rosa and winged euonymus. The goal would be to prevent, control and eliminate these invasive plant species. Based on initial research, it appears that MJJ Properties and Calloway Group, Inc. are the adjacent property owners on the Seymour side of this parcel.

Commissioner Minnick noted that he has walked the site and explained that the vehicles are coming in on the Seymour side through the old trails. The tire tracks are humangous. They are coming across the brook and to the Beacon Falls side.

Jim Galligan, Town Engineer mentioned working with the Public Works Department in Seymour to move the large boulders back which were previously there.
