New Applications

Application A-2012-298 – R.S. &J. Development - 45 Pines Bridge Road

Michael H. Horbal, Registered Land Surveyor with an office at 52 Main Street in Seymour, CT came before the Commission representing the Pruzinsky family/a construction company located on 45 Pines Bridge Road. They will be pursuing a regrading and excavation permit from the Town Planning and Zoning Commission. They are required to get approval from this Commission for wetlands and storm water management. The application and drawing (5 sets) has been submitted to the Commission. The application is for the excavation and grading for a building pad for a future commercial building. The drawings showed a future 15,000 square foot building with approximately 75 parking spaces. The site is hilly and steep. In order to build, the construction company will have to excavate the property to level it off. Half of the property was leveled in approximately 1986-87. The applicant at this time wishes to level the westerly half of the parcel to the intersection of Rimmon Road. The excavation calls for 65,000 cubic yard to be done over a 24 month period. The plans are outlined to show how they will proceed. The plans show a proposed grading plan, sediment and erosion control plan and details and the construction sequence. Hydraulic computations which conform to the Regulations of the State of Connecticut

for runoff and an application for storm water have been submitted. There is an executive summary included. There is a proposal as to how the storm drainage will be done. There will be a temporary sedimentation trap; then there will be permanent detention basin. They are planning to attend the next meeting of the Planning and Zoning Commission on July 19th. Because of the amount of excavation and blasting to be done, the Planning and Zoning Commission must have a public hearing.

David Keating, Wetlands Enforcement Officer stated he does not know of any wetlands on this site. Michael Horbal stated when the original proposal in 1985 was made, the plans at that time showed there were no wetlands on the site. Permits were granted by this Commission in 1985 and 1989 for the excavation at this site. There were no wetlands shown on the plan.

Vice Chairman Stephen Knapik stated that we are all familiar with the site. It is steep and pretty much all rock. Michael Horbal stated there are no wetlands or watercourses on the site. Dave Keating, Wetlands Enforcement Officer stated that to west of where Rimmon Hill Road is now, there is a spring. Michael Horbal stated the spring has never been part of this property. The existing road was moved to the east from the original location. There will be a tie in to the State drainage system. Michael Horbal stated that after the clearing is done, the filter fence will be installed and then the temporary sediment trap needs to be created. There will be a sediment trap with an inlet pipe on a riser that feeds into an existing catch basin located on the Pruzinsky property.

Motion was made by Commissioner Richard Minnick and seconded by Commissioner Walter Opuszynski to receive the application for processing and review.
