Darin Overton, Milone & MacBrrom representing Chatfield Farms gave an update of what has been done on the site. Mr. Overton stated that the only remaining item is the outlet structure. Part of the work has been done. A temporary fix is working fine. A trash rack has been installed as a safety measure. Vice Chairman Knapik asked who will be the contractor on site to maintain the property. Matthew Gilchrist of EG Group, LLC stated he will be the contact person. Mr. Gilchrist stated the plans have been reviewed. AM Alexandria will stay on as the land owner. EG Group, LLC is the developer and partner. There are 31 units in the first Phase to finish.

Commissioner Richard Minnick stated a couple of meetings ago; there was a request that a letter be sent requesting information regarding the stockpile on the site. The hill side is totally unstable. There is no way to stabilize it. What is the plan for the stockpile? The letter has to be put together. The fixes on the site are temporary fixes. The wetlands need to be protected. Mr. Matthew Gilchrist stated that within the next six months, they will be reengineering the back phases. They will be working with Malone and MacBroom to solve the problem of the surplus of material. Chairman Edward Smith stated that the plans will have to come back to the board for review. Monthly reports are required by the Commission. A representative from the Chatfield Farms – Homeowners' Association presented his concerns to the board, Matthew Gilchrist and Darin Overton.

Commissioner Richard Minnick asked if anything has to be done on the calling of the bond. Chairman Edward Smith stated that one item that needs to be taken care which is the dam. Maintenance is still needed. The punch list has been taken care. There is concern regarding the stockpile.

#### **Comments from the Public**

Mr. David Annelli, 17 Oak Drive, Beacon Falls, CT came before the Commission concerning a problem with 19 storm drains from the town road and Sharon Drive dumping and running on his property. It is making more wetlands than he had. The added water over the years and added storm drains has made the wetlands much larger. Can the water be contained by piping or possibly building some type of trench? Chairman Edward Smith asked when the garage was built on the back of the property near where the wetlands are. Chairman Edward Smith asked for a copy of the permit for the garage. There is water running out of the two pipes when it is not raining. Chairman Edward Smith stated that a site walk will be done. Commissioner Richard Minnick asked if the material has been removed which was piled in the back of the garage into the wetlands. There was material blocking the watercourse. Chairman Edward Smith stated that some logs were removed to free up the channel. Commissioner Richard Minnick stated the solution may be a channel mitigation.

Mr. David Annelli also stated his concern if anybody's oil tank lets go or there is an accident which causes a fuel leak and it goes into the storm drain and goes into the wetlands. When it happens, who will deal with it.

NOTE: Vice Chairman Steven Knapik noted that eight catch basins go through an easement that the Town has in his property and three more catch basins go down through Oak Drive.
