#### 1. Call to Order / Pledge of Allegiance

Chairman John Smithcalled the meeting to order at 7:30P.M.

Members Present: John Smith, Stephen Knapik, Arlene Brumer, Bill Giglio, Michael **Opuszynski**, and Walter Opuszynski

Others Present: Dave Keating and Jim Galligan

Motion to rearrange the agenda to accommodate the public present: **Knapik/Brumer**;no discussion; all ayes.

#### 2. Comments from the Public

J. Smith asked if there were any comments from the public and there were no one from the public present at this time. Ricky Glenn, Brooks Landscaping, was present at tonight's meeting to discuss Beacon Hill, Beacon Valley Road.

Ricky Glenn, of Brooks Landscaping in Bethlehem, CT, indicated that he brought pictures for the Commission's review regarding the pond at Beacon Hill on Beacon Valley Road. The work on the pond is located between Avon Ct. and the unit on top. The pond is overgrown with vines, saplings, evasive species and anything 4" or less will be cleared out, and restoring the area to its natural point. They will be doing this by hand, with have a chainsaw on site, and a woodchipper that will blow into a box truck. S. Knapik asked if stumps will be pulled and R. Glenn indicated no, nothing more than 4" in diameter.

M. Opuszynski asked if this is a maintenance activity or aesthetics and R. Glenn indicated that it is a maintenance activity and will be maintained going forward since it has been neglected over the years. R. Glenn also noted that the Association requested to have this clearing done and contracted Brooks Landscaping for the maintenance. W. Opuszynski asked if they will be going into the pond and cleaning the pond. R. Glenn indicated no, they are just responsible for the landscaping. W. Opuszynski asked when and how long will this take. R. Glenn responded immediately and approximately 2-3 days depending on the number of workers.

After a brief discussion, the Commission agreed that the activity is considered maintenance and a formal application is not required. J. Smith asked for D. Keating to contact the Homeowners Association and to review the agreement that is in place with Beacon Hill. After further discussion, an application number was assigned to the maintenance activity only for reference and a formal application is not required. A. Brumer confirmed that the application number for reference is #A-2017-312. The Commission requested pictures of before and after the work completed. The Commission also requested to have someone in attendance at the next meeting to update the Commission on the work completed.

#### a. Public Petitions

There were no Public Petitions presented to the Commission at this time.

#### 3. New Applications

There were no new applications submitted for tonight's meeting. The agenda references two applicants but formal applications have not been received and are on the agenda for reference only.

Keating explained that Erin Schwartz indicated that it was decided a few years ago that each Commission would have \$750.00 in their budget each year and to have each Commission pay their share of the invoice.
