1. Call to Order / Pledge of Allegiance

5. Administrative Report

Mr. Keating noted that he is continuing to coordinate with the Building Official the process for obtaining a Building Permit and to make sure that all Town Departments and Commissions have an opportunity to review and sign off for each project.

W. Opuszynski and A. Brumer noted that the last house is being built on the Tice project on West Road, just uphill from the detention basin. Mr. Smith said the house is almost complete.

Jim Weed has apparently started to dredge his pond on Rimmon Hill Road.

In regard to the detention ponds, it was noted that a letter will need to be sent to property owners about the ownership and responsibility of the detention ponds. D. Keating and J. Galligan will draft a letter and the Commission will review. W. Opuszynski suggested that a subcommittee be formed to work on this project. M. Opuszynski said that the first aspect to be implemented will be to notify the owners of their responsibilities and to make sure that the required work is carried out in an appropriate manner. The second phase will be to create a reminder and monitoring program to make sure that maintenance continues to be done for each detention pond.

b. Community Media Center Building Committee Report from Arlene Brumer

Arlene Brumer noted that contrary to the discussion at the previous meeting, there will <u>not</u> be a non-binding referendum about a possible Media / Community Center on the November ballot.
