



# BEACON FALLS ZONING BOARD OF APPEALS Regular Monthly Meeting October 9, 2014 MINUTES (Subject to Revision)

# 1. Call to Order/Pledge of Alliance

D. Bousquet indicated that he informed Mr. Piwonski that the application fee is \$375.00 and to be paid at the Public Hearing.
