- 2. Summary Report prepared by Emily Stockman of Stockman Associates for T. J. Crowe, response to enforcement letter of June 15, 2015 concerning possible wetlands violation on Crow property on Werden Road, Map 205 Lot 88. Continued from October 15, 2015.**
- 3. Request for Determination of Applicability from Sherwood Greens Road District, property adjacent to the entrance road off Rt.20, (Map 213 Lot 125) Relocation of existing postal boxes and installation of additional boxes in an open gravel covered area off the roadside and construction of a shelter over and around the boxes in the Buffer Zone of a Bordering Vegetated Wetland.**
- 4. Request for Determination of Applicability from Francis Clark on behalf of Camp Lenox, property at 2042 North Main Road (Map 205 Lot 71). Reconstruction, in the Shaw Pond Buffer Zone, of a 13x26 foot storage building that collapsed under snow load and was demolished in June 2015.**

Demolition of an existing 14x33 foot baking room on the existing dining hall and construction of a new baking room on approximately the same footprint in the Buffer Zone of Shaw Pond.**

Demolition of an existing single family house and associated garage structure in the Buffer Zone of an un-named beaver pond and Bordering Vegetated Wetland.**
- 7. Notice of Intent (DEP # 102-0411) from White Engineering on behalf of Rosemary Bleyer and Sally Baumer, property at #18 South Lake Way (Map 211 Lot 144). Jacking up an existing 3 bedroom house and resetting the house on a new foundation constructed of Techno-Metal Posts and steel beams in the Buffer Zone of Center Pond, Bordering Vegetated Wetlands and an Intermittent Stream.**
- 8. Notice of Intent (DEP # 102-0412) from White Engineering on behalf of Camp Greylock, property at 1525 Main Street (Map 210 Lot 17). Demolition of an existing 1950 sq. ft. Social Hall and construction of a new Social Hall on approximately the same footprint within the Buffer Zone of Center Pond.**
