FY 2013 Budget: discussion points for joint SelectBoard / FinCom meeting 11-April-2012

Recommendations

- 1. Reserve Fund: recommend \$30,000 to allow for more contingencies like demolition (see #3)
- 2. Building inspector expenses. Agree to +\$4,100/year for software/kiosk ONLY if SB increases building fees to offset the costs. 300 "actions"/ year avg +\$15/ea would cover costs. Bldg inspector says our current fees are very low compared to other towns.
- 3. Demolition fund. Recommend against increase. Suggest SB get town counsel to render legal opinion about our liability.
- 4. Town Acct Salary. Change line title to "Town Accountant" or "Accounting Services" & amount to \$14,500. This is really an annual professional services fee not salary.
- 5. Police Dept. Salary. TA proposed \$219,600. FinCom recommends \$202,000 which is F/T chief w/ benefits; without backfilling 1x P/T @ 17.60/hr x 1000 hrs. Total hours are flat.
- 6. Town Reports. Recommend \$3,000 based on current year cost overrun
- 7. Literacy Network. recommend \$0 unless they are really serving Becket citizens
- 8. Stabilization. recommend \$50,000
- 9. Added lines for previously debt-excluded purchases (\$ from Chris Bleu)
 - a. Fire truck: 3yrs. First 1/3 principal + interest \$109,285
 - b. Ambulance/Truck Bodies: 2yrs. Second 1/2 principal + interest. \$92,051
- 10. Dump Truck: removed from budget let it be debt-excluded 2 yrs. Hits FY 14/15 budgets.
- 11. In-sourcing Payroll: FinCom does not support. 5-year initial payback. May cost additional \$ to support the system with in-house personnel. Recommend that town employees hold outsourcer accountable for accuracy and if not performing, come to SB & FC with a proposal next year which includes new Outsource bids and total in-house costs.
- 12. overall recommendation allow the tax rate to go down. We have surplus levy capacity.

- 1. Veterans Benefits how do we get refund?
- 2. Voc Tuition any basis for numbers?
- 3. Health Insurance: Current FY \$329,000 +7.82% (\$25,728) +1 FT position should not be anywhere near the proposed increase of \$92,481 over FY12. Why?
- 4. Voc. Transport reimburse \$40,000 where does this come from?
- 5. Electricity: why are electric costs up? Didn't we lock in rates thru 2013? is anyone working on locking in future electric rates?
- 6. Our Local Revenues have been in the \$450K range in past budgets. Budget is \$425K this year. What is correct? Why the reduction?
