2. Transfers for end of FY 13

The following motions were moved by Ann Spadafora, seconded by Dan Parnell and unanimously approved by Ann Spadafora, Dan Parnell and Maria Wallington. SL arrived after all the Transfers had been approved.

- a. EG requested that two of the transfers approved on June 27 be rescinded. Motion carried to rescind transfer of \$1,442.94 from Vocational Tuition account #01-300-5500-5503 to the Vocational Transportation account #01-300-5500-5504 and transfer of \$4,898.25 from the 01-941-550 Reserve Fund to the Winter Road Salaries Account #01-941-5500.
- b. In accordance with Chapter 77 of the Acts of 2006: An Act Further Regulating Municipal Transfers of Appropriations **AS moved, DP seconded and the FC unanimously passed the following transfers of funds**:
 - \$2,000.00 from 01-156-5500 Postage Expenses and \$2,500 from 01-193-5800-580 Software Maint. (Total transfer \$4,500) to 01-300-5500-5504 Vocational Transportation.

 - iii. \$626.90 from 01-135-5100 Town Accountant Salaries to 01-431-5500 Transfer Station Expenses.
 - \$99.06 from 01-135-5100 Town Accountant Salaries to 01-129-5100 Town Administrator Salaries.
 - v. \$1,175.00 from 01-135-5100 Town Accountant Salaries to 01-147-5500 Tax Title Expense.
 - vi. \$114.03 from 01-176-5500 Board of Appeal Expenses to 01-175-5500 Planning Board Expenses.
 - vii. \$165.88 from 01-161-5500 Town Clerk Expenses to 01-161-5100 Town Clerk Salaries.
 - viii. \$547.56 from 01-135-5500 Outside Payroll Expenses to 01-241-5100 Building Department Salaries
 - ix. \$330.47 from 01-135-5500 Outside Payroll Expenses to 01-431-5100 Transfer Station Salaries.
 - x. \$1,714.06 from 01-192-5200 Municipal Building Utilities to 01-192-5500 Municipal Building Expenses.
