- c. EG detailed the following Reserve Fund Transfer request:
 - i. Request to transfer \$5,000.00 from the Reserve Fund (acct # 01-941-5500) to the Fire Rescue Pumper Capital (37-220-5500) to pay for mounting of equipment on the new Fire Rescue Pumper. This is the first of five Add Alternatives. The Becket Firefighter's Association will pay \$6,187.00 for the remaining 4 Add Alternatives

- b. Final payment for Bonny Rigg Hill Road project has been received
- c. A special town meeting may be required to transfer funds for:
 - i. Veteran's benefits account
 - ii. Health insurance
 - iii. Transfer station operating costs
- d. Did not receive \$6900 MIIA grant to purchase a radar trailer for work zone safety
- e. Did receive MIIA grant for flammable liquid cabinets
- f. Verengo pilot solar farm on Tanglewood Circle is being negotiated. \$100k payment has been received. Board of Selectman has opted for a flat annual payment
- g. 2018 Tax rate appears to \$10.87. Average single family home increase is \$81/year
- h. We have several pieces of obsolete equipment from computer to auction off
- i. Fire Station #1 (North Becket) window and door project is almost compete
- j. HVAC upgrade bids due at December 20, 2017 Board of Selectman meeting
- k. Financial Audit major highlights
 - i. Improve procedures over tax title properties
 - ii. Improve procedures related to ambulance activity

4. Broadband Update

- a. Mount Washington up and running with speed of 0.5 Gb/s
- Additional state funding for broadband from state of Massachusetts will be available for some towns
- c. Becket pole survey still in process (probably complete by end of December)
 - i. Taking physical measurements
