Ms. LaBelle opens the meeting at 10:00 AM in accordance with Massachusetts General Law regarding public health and explaining the rules of the meeting. The Selectman also read their opening statement explaining their rules of the meeting.

Joint Meeting: Abandoned Housing Initiative

Attorney General's Office:

- 1. Julie and Kerry Kuna
- 2. Julie advises no cost other than Agents time
- 3. Help towns with code enforcement and receivership if necessary
- 4. Deal with abandoned unoccupied properties
- 5. Law applies to vacant and unoccupied properties
- 6. Statutory Regs: court can appoint a receiver
- 7. Property where there are significant code violations can be rehabbed
- 8. Municipalities decide on properties to be recognized
- 9. Process: letters/petitions/photos/reports to be collected
- 10. Demand letter to be sent to all parties of interest
- 11. Towns can refer or recommend a list of contractors that may be interested in becoming a receiver
- 12. Receiver is paid when property sells- Town taxes and services come first
- 13. Free legal advice

Charlie advises when specific property is being discussed, an executive session should be considered. Each one will be case by case.

Questions from the Boards:

Ms. Pryor asks if this only applies to the Sanitary Code or also the Building Code. It is stated both can be addressed. Ms. Pryor states the town is working on a vacant property By-law.

Robert Ronzio discussed that the Planning Board may have input of importance regarding nonconforming lots. Many of the properties don't have a bank involved at all- the owner can be the only one involved.

Colleen O'Conner askes the staff of attorneys if there are any options for homeowners. There was grant money years ago and they are not sure any money is left from the grant.

Mr. Krawet makes a motion for a court order be issued for 676 Main St- some repairs need to be done to bring it up to code. Ms. Burgwardt seconds the motion. All in favor. Motion passes. Mr. Krawet makes a motion to move forward with AG's program at 676 Main St. Ms. Burgwardt seconds the motion. All in favor. Motion passes.

Selectman: Ms. Pryor makes a motion to move forward with the AG program with receivership to 676 Main St. Ms. LaDue seconds the motion. All in favor. Motion passes.

Ms. Burgwardt makes a motion that Mr. Kaniecki- Health Agent, work with the AG office on all future properties. Mr. Krawet seconds the motion. All in favor. Motion passes.

Ms. Pryor makes a motion that Mr. Kaniecki work with the AG office on all future properties. Ms. LaDue seconds the motion. All in favor. Motion passes.
