## B. New

  - **4.** ZBA Special Permit application for 1725 Main Street (Map 210, Lot 33): a permit is needed to replace the front porch. There is no historical significance to this property, so the Historical Commission has no objection to this permit.

  - B. MHC will determine the feasibility of a study on the restoration of the apothecary (1850's.) It's best to tackle this piece by piece, i.e., roof, basement, windows, etc. Sandi made the motion and Rita seconded it to give Gail permission to represent the Historical Commission as its liaison in regard to the apothecary and other town properties. All approved of this vote. We can apply for a 50/50 MHC Grant to do this feasibility study, but it cannot be done until we own the property.
