

# **SHERWOOD GREENS ROAD IMPROVEMENT AND MAINTENANCE DISTRICT**

## **PRUDENTIAL COMMITTEE MEETING MINUTES**

**September 6, 2014**

The meeting was called to order at 9:52 AM.

Present were Prudential Committee members: Joe Gaze, Michael Lavery, Shawna Garanzuay and Terry Hayden. Also present were: Jaime Garanzuay, District Superintendant; Jeanne W. Pryor, David Neelon, Carl Neelsen & Elizabeth Saunier, Stan Locke.

The minutes for the August meeting were reviewed as amended and accepted. (Michael will send to Mary and the board).

### **DISTRICT SUPERINTENDANT REPORT:**

Mike Callahan from Beaver Solutions came in to Golden Fawn Lake and Little Long Bow. The cage at the end of the beaver deceiver was replaced on Golden Fawn lake due to age and disrepair (rusted). Also the piping was changed to increase flow. The grants have been applied for at Silver Shield. MSPCA may not approve the full grant this year due to more applicants applying. Amount paid to Beaver solutions was \$885.

Japanese Knotweed, issue on Long Bow west with the plant reducing the right of way. Ernie will work with Jaime to get the weed removed. Board approved \$1000 allotment to get the road and right of way cleared.

The roads were mowed on the sides.

Mr. Mednick's letter was discussed. Old Abbey Lane was improved to get the flow of water correct.

The Road report was accepted.

### **LAKES REPORT:**

Ken Einhorn was not present.

### **Other Roads Issues:**

Stan Locke sent a letter to the board via email regarding signage. Stan Locke's request to put signs up at the ends of Long Bow Lane East where they are missing. The signs have been ordered and will be put up once they arrive. Three signs have been ordered to remedy the issue.

Tree trimming, additional signs were brought up for further review by the board. 911 signs were discussed, they are issued by the fire chief. Link to the instructions :
