- 03-12-2018, Lieutenant Governor Polito letter to praise Becket for completing the best practice chosen as part of its Community Compact which the town signed with the state on 12-22-2015. Becket and 16 other communities joined the Southern Berkshire Shared Services Project to complete the best practice and make improvements in how the various school districts deliver services.

- O3-22-2018, MassDOT copy of letter to the Town of Washington re: Dalton's request that the state consider instituting a heavy truck ban on Washington Mountain Road. MassDOT also specifies that the weight restricted bridge, which is not structurally deficient, on Route 8 over Shaker Mill Brook is not prioritized for replacement within the next five year cycle of MassDOT's Capital Investment Plan.
