- Team needs to roll out info in a controlled way talking about the benefits of the programs, then follow with the costs and speak about how it's far less than the previous \$42 mil figure, all the while meeting with community leaders to build support, then call a meeting with the delegation in Oct / Sept.
- Ross has copies of the power point presentation used for Sullivan, which can be updated with current trends and data, staffing plans,
- Need actual data on the counties recidivism rate.
- Debra suggested the need to get the criminal justice committee back together.
- Comm. Devoy believed the same courtroom should be used, same people invited.
- 6.6 Construction: Comm Devoy asked when could we begin construction? Andre suggested that the best time of the year to get estimates is mid-winter in preparation for a spring start. Earliest would be spring of 2016. For this to occur, SMP would need to continue with the design drawings to have them completed in time. Comm Devoy asked SMP to submit a proposal for the next phase of work.
- 6.7 Andre explained the different project delivery systems to available for construction: TEAM
 - CM construction management system is open book, where the construction manager gets a fee to be an advocate of the Counties behalf. Any savings found goes back into the project or back to the County. This CM should be selected soon, during the same time frame when SMP is developing the documents. Allowing the CM to assist with check estimates and helps steer the project to the desired costs. Potentially fewer change orders, a possibility of use of local sub-contractors. A CM has a full time superintendent verifying the every detail is correctly completed.
 - Alternative is have SMP fully complete the dwgs and put them out to bid. Where every GC general contractors submits a bid for the work. This method does not provide as much county involvement / control. Low bidder will make adjustments to the project to save money, not all returns to the county. Change orders are typical priced out at a higher percentage. A clerk of the works should be involved in bid job to confirm every detail is correctly completed.
