Commissioners Meeting Minutes May 16, 2012

Commissioner Philpot called the Belknap County Commissioners meeting to order at 5:30 PM on the above date at 34 County Drive, Laconia, NH and started with the pledge of allegiance.

In Attendance: Commissioners Edward D. Philpot Jr., John H. Thomas, Stephen H. Nedeau and County Administrator, Debra Shackett.

<u>Video Arraignment update</u>: Superintendent Ward gave the Commissioners an update on how this technology has been working. So far, 41 video arraignments have been conducted since it was installed on 4/16/12. There were a few technology issues that came up, and they have all been taken care of. It re is working great and has cut down on transports for the Sheriff's department. There is much efficiency that will be gained by utilizing this technology. The Commissioners thanked him for the update.

Commissioner Philpot reported that he was the key note speaker at last night's Genesis Behavioral Health Annual Meeting and it was great! He also reminded everyone that May is Mental Health Month. Commissioner Nedeau reported that he will be attending the Laconia Airport Authority meeting this evening.

Entrance at this facility: Commissioners asked about the new sign and flag poles that will be constructed at the entrance of this facility. Administrator Shackett reported that the flag poles are here and that Mr. Muzzey has three quotes for the stone wall that will be constructed. Administrator Shackett and Mr. Muzzey will look at various samples. The Master gardeners through UNH Cooperative Extension will design the area and we will use inmate labor.
