<u>Administrators report</u>: Administrator Shackett reported that she will have the results of the RFP's for the jail planning committee meeting on Tuesday, 6/5/12 at 4:30 PM.

Commissioner Philpot reported that Genesis is still dealing with funding issues in the current economy.
