<u>Contract Authorization:</u> County Attorney Melissa Guldbrandsen introduced the new Assistant County Attorney R.J. Meurin. R.J. Meurin presented to the Board two different online research

vendors. M/Burchell, S/Taylor to approve the contract with Westlaw subject to there being a 90 escape clause. Unanimous. **Motion passed**.

Section 125 Plan: County Administrator Debra Shackett explained the section125 being offered through NH Interlocal Trust. Commissioner DeVoy read the following: RESOLVED: That the Plan be amended and restated in the form attached hereto, which Plan is hereby adopted and approved; RESOLVED FURTHER: That the appropriate officers of the Company be, and they hereby are, authorized and directed to execute the Plan on behalf of the Company; RESOLVED FURTHER: That the officers of the Company be, and they hereby are, authorized and directed to take any and all actions and execute and deliver such documents as they may deem necessary, appropriate or convenient to effect the foregoing resolutions including, without limitation, causing to be prepared and filed such reports, documents or other information as may be required under applicable law.
