Opt Off Analysis Health Insurance: County Administrator Debra Shackett stated a survey was conducted for employees for the opt-off health insurance incentive. A summary was provided. No action was taken.

RFP Recommendation Electronic Monitoring: Superintendent Keith Gray stated three companies submitted proposals for electronic monitoring. The costs were reviewed.

Superintendent Gray stated he would like to do another RFP once the new community corrections facility is up and running for a year. He is recommending we continue with Track Group. M/Taylor, S/Burchell to accept the recommendation from Superintendent Gray. Unanimous. **Motion passed**.

Other: Commissioner DeVoy discussed costs the Sheriff's department charges for outside detail. He would like to raise the amount billed to \$60/hour. Commissioner Burchell stated he thought it is a good idea and is troubled by the cost to the County due to concerts at Meadowbrook. Commissioner Taylor agreed with Commissioner Burchell. County Administrator Debra Shackett confirmed that the hourly rate will be \$60.00 plus \$25.00 for vehicle use. M/Taylor, S/Burchell to increase the hourly outside detail billed amount to \$60.00. Unanimous. Motion passed.

Public Comment: There was no public comment.
