<u>Tax Anticipation Note:</u> M/Taylor, S/Burchell to authorize Treasurer Michael Muzzey to borrow up to \$10 million in anticipation of taxes for next year. Unanimous. **Motion passed**.

<u>Open Sealed Bids:</u> Commissioner DeVoy opened the bids received. The following companies submitted bids for the commercial dishwasher: Douglas Equipment, Ketridge and Sam Telecompanies. The following companies submitted bids for the washer extractor: Tristate Laundry Systems, Garment Machinery, Yankee Equipment and Daniels Equipment. All bids

will be reviewed by Environmental Services Supervisor Dan Riley who will make a recommendation to the board.

<u>Encumbrances:</u> M/Taylor, S/Burchell to encumber \$65,000.00 from the 2016 budget. Unanimous. **Motion passed**.
