<u>Restorative Justice Accreditation:</u> Restorative Justice Director Brian Loanes asked the Commissioners to sign the accreditation letter. M/Waring, S/Taylor to approve signing the accreditation letter. Unanimous. **Motion passed**.

<u>Authorization to sign therapy contract:</u> M/Waring, S/Taylor to authorize Nursing Home Administrator Richardson to sign the therapy services contract with the stipulation that it is in line with the RFP. Unanimous. **Motion passed**.

<u>Other:</u> Commissioner DeVoy inquired about the RFP's for health insurance, IT services and phone services. Administrator Shackett stated they are being worked on.
